MCO IN DISCUSSIONS WITH OSE

LOCAL 517 ADOPTS CHANGES

MCO has been in discussions this week with the Office of the State Employer regarding ways to find cost savings and avoid, if possible, the Department unilaterally forcing savings through more drastic means.

As mentioned in an earlier KYI, Local 517M had sent a package to its 3 bargaining units for a vote to amend its contract. All three units approved the changes by 64% to 73%. The major change extends its contract another year and therefore freezes Health Care benefits at the current rate until September 2012. However, new employees hired after April 2010 would be required to pay 20% of premium and deductible and prescription costs would also increase **Stay tuned**.

MEDICAL MARIJUANA

MCO has received several calls in regard to the recent Medical Marijuana law. The union is talking with its lawyers on the broader issues, however the Department has the authority to implement/amend work rules. All officers should sign the medical marijuana work rule document. Please know that by doing so, you are only acknowledging that you have received the document.

CRITICALS AROUND THE STATE

Bellamy Creek - fight outside chow hall on 11.10.09. 9 inmates sent to Seg., shank found and 2 officers assaulted. Also 1 inmate to Seg. for assaulting officers with a cane - and then spit on them during escort.

Gus Harrison - on 12.3.09 a RTP inmate, with a history of assaults, resisted/pulled away from staff while being escorted to his cell. Officers had to take him to the ground and in the process one officer fractured his kneecap. On 12.6.09 Level II prisoners began grouping up in 3's and making laps around the yard for 20 minutes. Approximately 40-50 inmates were involved. Reason for protest yet unknown. Dusk closure of back yard leaves 3-5 yard officers for 720 prisoners in a darkened yard.

Egeler/DWH - Inmate punched an officer in the face when they entered his cell at Duane Waters Hospital. Prisoner continues to be a problem, refusing his psych meds despite being in a Medical facility. Officer treated for exposure.

Parnall - On 12.18.09 two groups of about 50 inmates faced off on the yard. Additional staff were sent out to break up the groups. Shanks crafted from a screwdriver and aluminum nails were found, along with a metal rod in a pool of blood. Shakedown called, but doing HU 1/day instead of blowing whistle and doing it all at once.

OFFICER OLIVO UPDATE

Officer Sam Olivo, who was brutally attacked on December 8, 2009, is back recovering at the Origami Brain Rehabilitation facility. Sam returned to the hospital just after Christmas for treatment of an infection, meningitis and a blood clot.

He continues to receive cards and support from officers and facilities around the state.

TENTATIVE AGREEMENT REACHED *Membership Vote to Come*

Keeping You Informed

MCO and the Office of the State Employer have reached a tentative agreement on a contract extension and amendments. In short, MCO's contract would be extended one year, expiring December 31, 2011.

The extension would mean that current employee health insurance costs would be frozen until September, 2012. However, new employees hired after April, 2010 would be in a "New Hire State Health Plan", which includes a 80/20% premium split (85/15% HMO), increased deductibles, co-pays and prescription costs.

The State was intent on extracting a total of \$8.2 million from the security bargaining unit for this fiscal year. It agreed to "credit" MCO a total of \$7.6 million for the elimination of line-up, but needed another \$600,000 which it would have taken in other ways --- perhaps closing positions, etc. To mitigate that harm, MCO obtained 3 hours of Banked Leave Time which equates to \$600,000.

Most notably, MCO was successful in gaining a Sick Leave/Overtime Reduction Pilot Program that if successful, would mean officers could get a payout of 50% of the sick leave earned during the pilot. State employees have been trying to secure some type of sick leave payout since the 80's. If this does end up saving the state in Overtime costs (through less sick leave usage), then it is a win-win as the DOC finds savings, and our members have an opportunity to cash out some sick leave.

MCO corrected an inequity for 3rd shift employees during the pilot period cited above. If a midnight officer works any overtime beyond their shift, and then happens to call in sick that evening for their original shift, they will receive overtime pay regardless.

Chapter Presidents are being briefed today at MCO Central in Lansing, and the complete details will be available on MCO's website by Monday, January 18th.

Voting packages are being prepared and should be in the mail by January 25th. This will be a very short turn around due to the next scheduled Civil Service meeting which must approve this agreement if passed by a membership vote. Ballots will need to be returned no later than February 9, 2010.

St. Louis Officers **STABBED**

Two officers were stabbed on January 14, 2010, when an inmate serving a life sentence attacked them during a shakedown for special diet chow line. The inmate used a shank made from metal, believed to be missing from the HU 5 small yard, to stab the officers in the chest and arm.

The officers were sent via ambulance for treatment. They sustained serious puncture wounds but were thankfully treated and released.

The inmate was placed in Segregation, where he later died. Final cause of death has not been determined, however preliminary reports indicate a heart and support from officers and attack.

ALGER FIGHT

A group of inmates were walking the track on the big yard together at the Alger Correctional Facility on January 19, 2010, when a fight broke out. It began between two inmates, but then spread when three more jumped on each other. While officers were trying to restrain some fighters, the others used the opportunity to kick the restrained in the head and body.

Three prisoners were transferred out to Marquette Branch, and the rest are being held in Segregation.

Criticals earlier this month include a Jan. 1 fight on the big yard, refusals to lock up, an RUO assaulted in GP unit on January 2nd, prisoners to Seg on Jan. 3rd & 5th for threatening staff, weapon found in weight pit on Jan. 5th, chow line fight and failure to disperse on Jan. 5th, inmate with weapon on Jan. 6th, prisoner assaulted officer in transition unit during breakfast chow lines Jan. 7th, inmate with weapon Jan. 8th, fight on Spruce Yard on Jan. 12th where two inmates were sent to Seg, and two staff hurt (one still off)....among others.

SHANKS AT KINROSS

An officer on the afternoon shift at Kinross on Jan. 17th, found eleven shanks in a four man room. All four were sent to Seg... one of whom became combative and threatened an officer on the way.

First shift officers the next day found two more shanks in a porters closet, approximately 14" long, and believed to have come from window frame material.

OFFICER OLIVO UPDATE

Officer Sam Olivo, who was brutally attacked in December, continues to recover at the Origami Rehabilitation Brain facility in Mason.

He continues to receive cards facilities around the state.

SEG. REVOLVING DOOR

In a ten day period in late November at the Thumb, a continuous stream of inmates from the Franklin unit cycled in and out of Seg. Inmates were starting fires, breaking out windows and lights, throwing urine and more on officers through food slots, assaulting staff while having restraints applied and/or removed, and more.

In all, 17 inmates were sent to Seg., and another 12 were bonded out and placed in single cells. Two officers injured in one incident were treated at the local hospital and returned to finish their shift.

REPUBLICAN ATTACKS CONTINUE!

Senate Republicans, led by Majority Leader Mike Bishop, have introduced a so-called "reform" package that claims potential savings of more than \$2B for the State of Michigan. The proposal includes:

- Public Employee Health care (\$615M savings)
- Local police and fire (\$70-118M savings)
- K-12 school spending (\$363-663M savings)
- Medicaid spending (\$160-500M savings)
- Government efficiency (indeterminate)
- Public Employee Compensation (\$1.2B savings)

Of note to us in Corrections, this package would require public employees to pay 20% of their health care premiums and would implement a 5% pay cut for all public employees and freeze it at that level for 3 years!

The Legislature would be required to pass the reform package by a $2/3^{rds}$ vote in order to put it directly on the ballot. If they fail to pass it with $2/3^{rds}$, they have not ruled out the possibility of conducting a petition drive in order to get it on the ballot this fall anyway.

More Shanks at Kinross

Back in December, there were several notable shanks found at Kinross... a 7" shank on a prisoner in E unit, an ice pick style shank on a prisoner in G unit, and then a fight in the north yard between at least four prisoners, one of whom ended up with superficial puncture wounds. Officers later found a shank in the snow.

The shanks continue, and on January 23rd, an officers did a personal shake down of an inmate due to suspicious activity. Upon shake down he had four shanks upon his person. Then, when officers did a shake down of his room they found one more shank and a "file-like" sharpener. The shanks were highly crafted with leather handles to protect the user.

GOVERNOR'S REFORM PACKAGE INCLUDES HITS

The governor has announced \$450M in "reforms" for the upcoming fiscal year that continues to find savings from all public employees. The plan would include a mild incentive for those eligible to retire by this fall, to receive an increase in the pension factor from 1.5% to 1.6%. For those that don't do so, penalties will occur with the most severe being a loss of dental and vision benefits once they do retire.

In addition, all state employees in the defined benefit system (old retirement) would be required to contribute 3% of their salary towards retirement. After working 30 years, those employees would be moved into the defined contribution system for the rest of their work lives.

Notice to state employees and their unions was just received today. We will publish more details next week as we get certain answers to questions we have concerning covered employees. The changes would need to pass the legislature before taking effect.

The above proposal further hinders MCO's effort to get an early retirement bill passed





CONTRACT EXTENSION & AMENDMENTS

BANKED LEAVE TIME

PLEASE EXPLAIN THIS IN MORE DETAIL. CAN WE USE IT RIGHT AWAY? WHEN DOES IT BEGIN?

The state needed to find an additional \$600,000 in savings. They agreed to 3 hours of BLT to get those savings.

Banked Leave Time (BLT) is time that you work, but are not compensated for right away. In this tentative agreement, it is a *total of 3 hours* during one payperiod, for which you will not be paid. These are actual worked hours for which you are "banking" the time.

You can then either use BLT like annual leave, or save it and get compensated for it at your final rate of pay when you leave state service.

MCO bargained to have the 3 hours of BLT taken care of in the first pay-period containing a holiday should this agreement be ratified by the membership. This was done since most employees would be getting holiday pay and thus wouldn't feel the cut as much. Unlike the BLT from 2003/2004... this is a one time event...for a total of 3 hours.

Is OUR OCTOBER 3% STILL ON? The 3% raise for this October (FY '10-11) is completely separate. It takes a 2/3^{rds} vote by the Legislature (within 60 days of the Governor presenting her budget in Feb.) to overturn it. This is the case whether or not this tentative agreement is ratified.

SICK LEAVE/OVERTIME REDUCTION PILOT

IF THIS IS DEEMED UNSUCCESSFUL, CAN THE SICK LEAVE EARNED DURING THE PILOT STILL BE CASHED IN?

If the Sick leave pilot program is deemed unsuccessful, no time can or will be cashed in. However, we would immediately revert back to our current contract language regarding the Sick Leave Use and Physical Fitness Bonuses, retroactive to the start date of the pilot program. Thus, if you would have been otherwise eligible to receive the Sick Leave and/or Physical Fitness Bonus had the pilot program not been initiated, you would still receive those bonuses.

WHEN CAN YOU CASH IN THE SICK LEAVE...NOW, OR AT RETIRE-MENT?

The Sick Leave Pilot program would be in effect from April 4, 2010 through April 2, 2011. At that point the state would evaluate if the program had "achieved the required overtime reduction" as a result compared to the previous 12 months. Therefore it is our understanding that if deemed successful, the time could be cashed in and payments received after the end of the program (April 2, 2011) and by the start of the next fiscal year (October 1, 2011).

Is Sick Leave earned prior to the pilot program eligible to be cashed in at 50%?

If the pilot program is a success, then the sick leave time that could be cashed in is up to 50% of the *time earned during the pilot*. Only those officers with 300 or more sick leave hours as of April 3, 2010 (no matter how much time you have in) are eligible under the pilot.

The maximum hours that could be earned during the pilot is 104 hours of sick leave. Assuming you took no sick leave days during the pilot you would be able to cash in 50% of the 104 hours... thus you would add 52 hours to your sick leave bank, and get paid for the other 52 hours.

If you were to use 2 sick leave days during the pilot, then you would have 88 hours of sick leave remaining. Thus, you would be able to cash in any amount up to and including 44 hours of sick leave (50% of the remaining 88 hour balance).

If you only had 12 hours of sick leave left, then you could bank 6 and cash in the other 6 hours.

FIGHTS & SHOTS FIRED AT ALGER

Jan. 18th: 3 to Seg. for assaulting a prisoner, failure to disperse and refusing to lock up.

Jan. 19th: 9 to Seg. for fighting on the big yard.

Jan. 20th: 1 to Seg. for razor blade in cell and 2 to Seg. for fighting in the transition unit yard.

Jan. 21st: Inmate attempts suicide by cutting himself. Required massive blood transfusions but was saved.

Jan. 22nd: 5 to Seg. for assault/ fighting. Four inmates were beating on a 5th, hitting and kicking his head. A warning shot was fired, but the blows continued. After a second warning shot, the prisoners ceased their attack.

Jan. 23rd: one to Seg. for threatening behavior on staff.

Jan. 24th: one to Seg. for threatening behavior on staff.

FOUR OFFICERS ASSAULTED

An RTP inmate at Huron Valley Womens injured four officers in an assault on January 26, 2010. Three officers were sent to the hospital for treatment... two by ambulance.

Then, when officers were escorting her to segregation, she assaulted the Acting Sgt., spitting in their face.

BALLOTS DUE!

If you have not received your Ballot package and would still I l like to vote, the only way to do so is to come to MCO Central I Office. Due to mail time limits we can no longer mail out replacement ballots. Only ballots received by 9 a.m. on Feb. 9th will be counted.

RETIREMENT PROPOSAL DETAILS NOT YET

FINALIZED

MCO has talked to the state budget director indicating our opposition to the announced retirement proposal. The union also argued that certain components needed to be addressed and considered for those who are in covered positions.

Legislation is being drafted for introduction with the Administration indicating the final package and exact components have not been absolutely finalized at this point.

Once formally introduced in the legislature, MCO will continue lobbying. Since the budget office cannot answer every question yet, stay tuned to the KYI --- we will give you information as it unfolds.

INMATES ACTING OUT AT MID-MICHIGAN

During January shanks were found on at least two occasions. One shank measured about 6" long and another 9" long.

On January 31st. an inmate in Funit became very hostile, threatening staff and their families and refused to cuff-up. It took 1 Lt. and 3 officers to take him down and secure him. All officers walked away with minor injuries as a result of the take-down. This inmate had been screened out as a Level II a couple of weeks ago but was catching major tickets.

As these "so-called Level I" inmates are being dropped from Level II and IV the critical activity has increased.

LOCK-IN-SOCK AT SMT

On January 10, 2010, a prisoner pulled the fire alarm causing the unit to be evacuated to the yard.

Once in the yard, four prisoners attacked a fifth, using a lock-ina-sock. The inmate was hospitalized and underwent brain surgery as a result.

Without a camera on the alarms, inmates are able to use them as a method of protest or as a diversion with no ramifications or ability to be identified.

BUDGET PROPOSAL WOULD SLASH 5 MORE PRISONS

Faced with massive revenue shortfalls, the Governor introduced her FY 10/11 budget recommendations today. The proposal calls for cuts throughout the state system, including reductions in correction spending through so called prison reforms. The Governor called for the passage of House Bills that would allow the reinstatement of "good time credits" as well as the use of electronic monitoring to reduce the prison population by an astounding 7500 prisoners within four to five months. The effect of that kind of drop in inmate population would cause the closure of up to five more prisons for a projected savings of \$129M.

Additional hits called for recently by both the Governor and Republican leaders include:

-eliminating vision and dental coverage for future retirees.

-requiring employee contributions to help offset growing pension obligations. -capping employee participation in the defined benefit retirement plans at thirty years, and thereafter transferring employees to a defined contribution plan. -cutting state employee wages by 5% and freezing it at that level for 3 years. -increasing health insurance premium costs to an 80/20 split for all state employes.

Without tax restructuring in Michigan, the state will continue to suffer major budget challenges for several years. If revenues do not increase, cuts are the only way to balance the budget as required by the constitution.

Governor Granholm also calls for a balanced budget to be passed by June 30th. Further, as it is an election year, the legislature will likely accelerate the budget process in hopes of returning to their districts this summer to campaign.

The Governor's budget proposal is the first step in the budget process. This year the budget will start in the Senate before moving on to the House...changing along the way. *This means that NOW is the time to start calling, writing, and lobbying your legislators on the dangers this plan poses. If this were to come true, Michigan will have closed 13 prisons and 10 Camps in two years!*





NERE'S LOSE 3%

The Civil Service Commission met on Wednesday, February 10th and voted to eliminate the October 1, 2010, scheduled 3% wage increase for Non-Exclusively Represented Employees (NERE's).

The Governor's budget proposal includes the 3% for state employees, however the legislature could revoke it by a $2/3^{rds}$ vote within 60 days.

FIGHT AT OJIBWAY

On January 24th, a fight broke out between two prisoners in G-Unit. The officer called for back up, ordered the inmates to break it up, and then took one inmate and turned him away from the fight and took him to the ground. The other inmate then jumped on the officer's back in an effort to try to get to the inmate.

Responding officers were able to get the prisoner off of the officer and restrain him. In the process, one officer was elbowed in the chest and two officers were treated for blood exposure.

The inmate was issued three Major Misconducts for Fighting (on staff), Assault and Battery (on staff), and Disobeying a Direct Order.

Two officers were also sent for treatment of blood exposure from another inmate on inmate fight back on January 18th.

OFFICER Assaulted

On February 12th, two Alger inmates were sent to segregation for fighting and another three for failure to disburse. During the incident, one officer was punched in the forehead.

In all, 14 prisoners were sent to segregation between Feb. 6th and Feb. 14^{th.}

OFFICERS RECALLED

After ongoing discussions between MCO and the Department, MCO was informed this week that five officers from the Standish layoff unit will be recalled to the St. Louis Correctional Facility. IN MEMORIAM Officer Donald Kistler, 60, of the Florence Crane Correctional Facility, passed away on February 11th, after collapsing at work. Officer Kistler was a US Army veteran and worked at Crane since hiring into the Department of Corrections in 1996. He leaves behind a son and

daughter, and nine grandchildren.

A memorial service was held today in Coldwater. Memorials may be made to the Heart Association.

BLT

As a part of the Contract Extension & Amendments that was ratified by the membership last week, a total of 3 Banked Leave Time hours will be applied to this pay-period. (March 4th pay date)

MCO had asked that the one time "banked-leave" event occur in a pay period containing a holiday to mitigate the impact for most of the membership.

These three hours of BLT can be either used later as leave time, or paid out to you upon your retirement.

YOUR ACTION NEEDED NOW!

LEGISLATURE PURSUING ELIMINATION OF 3%

The Senate Majority is gathering support and a vote to eliminate the 3% pay raise may come as early as next week. *This means that NOW is the time to start calling & e-mailing...lobby your legislators! - both Senate and House.* We risk life and limb every day on the job while faced with cuts to staffing, line-up and a classification system that pushes violent offenders into lower security levels to save money.

Corrections Officers and state employees have saved the state over \$650M in the last 5-6 years through increased heath care costs, closures, furloughs and more. This raise was bargained for in good faith over two years ago and should be honored. The state cannot continue to balance the budget by cuts to state employees... they have paid their share... and then some... already.

While the Governor included the negotiated 3% raise in her budget proposal on February 11th, it can be stopped by the legislature. *If the Senate passes this we think that it might pass the House...we need to stop it now!*

EARLY OUT FOR COs STILL NEEDS YOUR SUPPORT!

Recently, Governor Jennifer Granholm and State Budget Director Bob Emerson introduced what they are calling an "incentive based" retirement program for 7,000 state employees and 39,000 teachers.

The governor's plan does not, however, integrate MCO supported legislation **House Bill 5197** (Early Out for Corrections Officers). While our bill is still alive, it currently sits awaiting the opportunity to be taken up on the house floor.

MCO continues to lobby for HB 5197 and argue for its passage. You can do your part by calling and writing your elected officials and letting them know why COs deserve this early out opportunity.

WOODLAND/MAXEY TO POST OPENINGS

MCO has been notified that the Department will be posting to fill 14 CMAs and 14 CMUOs in the near future. We wanted to give you a heads up to watch for the notice and/or share with any laid off officers who might be interested. Once posted, the notice will provide instructions on how to apply.

STATE EMPLOYEES IN THE CROSS HAIRS

If you have been anywhere near a radio, TV, or newspaper this week you've heard that the legislature is making moves to eliminate the scheduled 3% pay increase due state employees October 1.

The Senate could vote on this as early as next week... *so we need your immediate action!*

MCO has done extensive lobbying already (direct letters to the entire legislature from MCO requesting a NO vote, meetings with top democratic Senate Leadership, meeting with Republican Senator Mike Nofs, talks with Speaker Andy Dillon, and more)...and will continue to put on the pressure. But - we need your help. Contact from constituents has a greater impact than just MCO officials alone.

MCO is launching an e-mail letter writing campaign this afternoon (if you're signed up for e-mail you'll get one from us automatically) that allows you to contact your legislator with just a few clicks of a mouse. If you aren't online... then give Jeremy Tripp at MCO (517.485.3310) a call and we'll help get you in contact with your elected representatives.

Time is of the essence!





While the Senate failed to pass SCR 35 this week which would have rescinded the 3% raise scheduled for October, they will take up the vote again. Thank you to the officers who have already called or written their legislators on this important issue.

SAGINAW SEES ACTION

On February 3, 2010, a Level IV prisoner being shook down threatened "I'll knock your head off" to an officer and proceeded to punch him in the face two times. Later that same day two more Level IV inmates were fighting in their cell and when an officer attempted to break it up he suffered injuries to his face requiring an MRI for possible facial fractures.

Then, on February 24th while feeding prisoners in the unit dayroom, an RUO was assaulted in the hallway by a prisoner after the officer asked him to comply with a shakedown. Several prisoners who observed this got up from their table and moved closer... eventually assaulting another RUO who came to help, before quickly returning to the day room to blend in with the non-involved inmates.

Staff response was excellent. Quick actions ensured that the guilty parties were identified and held accountable. One resisted during transport to Seg. and injured an officer. In total, three officers were sent to the hospital where they were treated and released.

MID-MICHIGAN INMATES ATTACK RUOS

Two inmates picked a fight with each other on Feb. 13th. The two RUO's assigned to the unit called for assistance and then tried to restrain the inmates. One was successful, however the other inmate broke loose and then assaulted both RUOs. Responding staff arrived and were able to gain control, however one officer was treated at the hospital for blood exposure, shoulder and back injuries.

Week of Feb. 1st - Feb. 5th

9 inmates to segregation for fighting, dangerous contraband and more.

Week of Feb. 16th - Feb. 23^{rd.}

10 inmates to segregation - 3 for having weapons on their person. In one incident the inmate refused to come out of his cell, the move team was assembled and he was shot 4 times with pepper balls and gassed but he still wouldn't come out. He assaulted the move team members with a padlock tied to a sock when they entered his cell.

Week of Feb. 24th - March 1st

15 inmates to segregation for refusing to lock up, possession of a weapon, dangerous contraband, assault, threatening behavior and more. On Feb. 24th an inmate handed a shank over to an officer stating that he had been given the shank by another inmate and ordered to carry out a hit. Further, on the 26th, a 7.5" shank was found in GP, the move team assembled and gas used on two bunkies on the 28th for refusing to lock up, and on March 1st an inmate assaulted 2 officers... one of whom has a broken collar bone and will be off of work for several weeks if not more.





MTU OFFICERS GRANTED VALOR AWARDS

Five officers from the Handlon Michigan Training Unit Facility were presented with the Valor Award on Tuesday, March 9, 2010. The Valor Awards, one of the highest honors for COs, were earned on July 15, 2009, when these officers stepped into the middle of a fight on the yard between two Islamic Groups, one of whom felt the other wasn't respectful of the holy book and had declared a jihad on the other and ambushed them on the yard.

The officers jumped into the middle, disarming them and protecting the two groups from each other in the process. Two officers sustained cuts and knife wounds in the process.

In true officer style, Officer Michelle Bey stated upon receiving her award, "I was just doing my job."

Multiple Injury Incidents at St. Louis

MARCH 9 - four staff were escorting a disruptive prisoner to his unit when the inmate threw off his coat, clenched his fists, and punched an officer in the head. Inmate was taken to the ground and cuffed. While being escorted to the showers, the prisoner again became combative and head butted an officer causing facial lacerations. The officer needed stitches for his injuries.

MARCH 10 - fight on walk to chow (2 inmates sent to segregation)

MARCH 11 - fight/stabbing on the walk. One inmate stabbed multiple times. Shank recovered.

MARCH 13 - 3 shanks found in inmate's shoe.

MARCH 14 - stabbing in chow hall. One inmate sustained multiple stab wounds and injuries from a trash can lid. Three officers to hospital for blood exposure treatment. Shank recovered.

MARCH 15 - mobilization and facility locked down - two shanks found in school building.

MARCH 16 - 6 involved in center walk fight during chow.

NEWBERRY INMATE STABBED IN BUNK

A prisoner in Q-unit was hit in the head with a blunt object and stabbed in the neck by an unknown assailant while lying on his bunk. This is the fourth such attack in the last three months in this unit.

The "L" shape layout of the unit and only 1 officer to 42 Level II inmates has made identification of the assaulter elusive.

MARCH 19, 2010

ATTACK AT MTU

A prisoner at the Handlon MTU facility entered an ARUS's office and attacked her on March 8th. The inmate grabbed her head/neck with one hand and swung in with a shank in the other. The ARUS was able to take him to the ground and yell for back up but he delivered several blows to her neck and back.

Both the prisoner and the ARUS were treated at the hospital and tickets were written for taking hostage, assault with a dangerous weapon, and possession of a weapon.

LEGISLATURE FAILS AGAIN 3% SAFE?

The Senate tried again on Thursday to eliminate the scheduled 3% raise for state employees scheduled for October 1. They failed, however, to get the required 2/3^{rds} majority...falling three votes short. All Democrats supported state employees except one, Senator Switalski (D-Roseville).

The legislature has left for a two week recess which puts them past the deadline of April 11th to stop the raise...so it appears safe.

OFFICERS ASSAULTED AT ALGER

When the small yard was returning on March 28th around 1630 hours an inmate swung at and struck an officer several times in the head. Unit staff and a Sgt. responded, but when they got the inmate to the floor 4 more prisoners jumped in on staff. Five more inmates ran interference - refusing to disperse and stepping in to block.

When it was all done, 5 inmates were sent to Seg. for assaulting staff, 5 for failure to disburse, and four officers were treated for various injuries ranging from facial lacerations and head and shoulder injuries to a concussion suffered by the initial officer attacked.

Several of these inmates have been involved in previous assaults on staff, and two have earliest release dates of 2038 and 2048.

Video shows the incident lasted approximately 60 seconds and I staff did an amazing job, even once they themselves had been assaulted.

In a related note, earlier that day another Seg. inmate had selfmutilated and three officers had taken him to the hospital, leaving the facility 3 below critical at the time of the above stated incident.

Homicide at Lakeland

An inmate, Derrick Lee, was found on the floor of the B-1 unit mop room at the Lakeland Correctional Facility at 2125hrs. on March 21, 2010. The inmate had sustained multiple stab wounds and an apparent blow to the head and was pronounced dead.

The suspected assailant has been identified. It appears that a verbal altercation between the two inmates escalated with Lee hitting the assaulter in the head with a softball size chunk of cement. The assaulter then went and got a shank, (6-8" sharpened metal rod), and returned to stab Lee 6 times in the chest and arms.

MAXEY OFFICER AT MERCY OF TIMED DOOR RELEASE

An officer who was observing prisoner activities in the day room at the Maxey Correctional Facility on March 25th, was hit in the face several times by an inmate. Officers watched the assault, but could not come to the officer's aid until the time released door system used at Maxey would allow them into the dayroom. Thankfully the officer was not seriously injured and the responders were able to subdue the prisoner.

April 2, 2010

SUPPORT FOR OFFICER BROWN A new hearing date has been set for Officer Brown of Bellamy Creek who is being charged for assault against an inmate despite being cleared by the MDOC of I any wrongdoing.

L MCO is in support of Officer I Brown and asks officers around the state to show up in uniform and pack the court room as a show of "Silent Solidarity."

The hearing is scheduled for Thursday, April 22nd, at the Ionia County Courthouse. Please arrive between 12:30 and 1 p.m. Your uniform should be squared away as this will be a very public display of our support.

MCO is calling on facilities to raise funds to help Officer Brown with her expenses. While the Department has made it clear this type of fundraiser cannot be held at the facility, we encourage you to be creative. Many institutions have indicated they will proceed off grounds. No matter how many l obstacles are in our way we must *I maintain solidarity!*



Twelve inmates were issued Major Misconducts for Fighting and two for Assault on Staff after a 20+ inmate brawl in the card room at MTU on Tuesday.

At approximately 1920hrs a Unit B officer called for assistance over his mobile radio for a fight. Two minutes later the officer radioed again requesting additional staff because the fight had increased in size and expanded into the hall.

A sergeant and 11 officers eventually brought the fight under control. B Unit was locked down and one weapon was found laying on the floor.

Two officers were sent to the injured however. local hospital for evaluation and treatment of their injuries.

RETIREMENT BILLS MOVE OUT OF SENATE

SB 1226 and SB 1227 passed out of the Senate with substitutes I Town Hall with on Wednesday. The original bills would have given a 1.6 multiplier, however the final bills adopted keep the multiplier at 1.5%. The provi- **When:** Monday, April 26, 2010 sions to make retirees pay for dental and vision, and to cap service at Where: Pine River Township 30 years, however, were removed. Employees would still be expected to make a 3% contribution towards their retirement. The bills passed along party line votes with Republicans supporting the legislation and Democrats in opposition - with two exceptions. Democratic Senator Switalksi voted in favor, while Republican Senator Kahn voted with the Dems against the bills.

These bills now move to the House. While the Governor's proposal would have saved \$500M for FY 2011, the versions passed by the Senate bring the savings down to \$225M.

The House has indicated it hopes to move on the legislation quickly, however it is uncertain if they will move forward with the versions sent over from the Senate, or if they will push their own legislation.

A Level IV inmate at the Chippewa Correctional Facility took a female social worker hostage in the education building on Monday, April 19th. **CARSON CITY 3.12.10** - officer

The inmate barricaded the door to the office shut, and had three shanks in his possession which he was wielding.

Officers responded immediately and were successful in breaking down the door and taking the inmate to the ground, freeing the hostage. In all, eleven staff members were treated at a local hospital for their injuries from the incident. Thankfully the social worker was not more seriously assaulted. *Officers did a fantastic job using their training and skills - working together to save her life.*

Series of Incidents at Carson City

3.12.10 - officer observes inmate acting suspiciously and calls him over to speak with him. Inmate enters back office, sits in officer's chair, and refuses orders to exit the chair. When the inmate finally does get up, he stands up abruptly intentionally slamming into the officer knocking him backward more than 4 feet. The prisoner is cuffed and taken to Seg. for Assault on Staff resulting in serious physical injury.

3.22.10 - officers observe an inmate running through the lobby chasing another prisoner with a broom handle. Both inmates were restrained, cuffed, and sent to Seg., with one being written up for possession of a weapon and Assault and Battery.

3.26.2010 - An inmate balked and physically resisted during a shakedown by a Sgt. in the chow hall. The prisoner grabbed the Sgt. when he neared his waist/pocket area during the shake down. A major misconduct was issued for Assault and Battery on staff.

Bellamy Creek Locked Down

IBC was locked down April 26th and part of the 27th to shake down the facility.

More than 75 metal rods out of 4 and 5 block as well as the big yard were recovered. Of the 50+ rods hidden on the big yard, more than a dozen were sharpened to a point, and more than 10 from the units were already fashioned into shanks with handles.



Maxey Inmate Found Hanging

An officer doing rounds at Maxey on May 5th, found a prisoner hanging. He immediately called for additional staff and removed the noose from around the prisoner's neck. Due to his quick actions and diligence, the prisoner's life was saved.

CUTS NOW...AND LATER?

Due to an additional \$47M shortfall in the current fiscal year budget, the Department has informed MCO that **Unsecured Level I housing units at Chippewa and Cotton will be closed effective May 28, 2010, and at Gus Harrison effective June 4,** 2010.

Additional savings will come from the consolidation of the Pine River and Mid-Michigan facilities, and dropping from 3 Regions to 2, losing 1 RPA and related personnel.

In addition, further cuts may be necessary to save on overtime, and the Department is considering, among other things, the following actions:

- » Shutting down Public Works programs
- » Closing gun towers at Mound and Ryan on midnights, and reducing coverage during active hours

MCO was alerted to these scenarios by the Department and has made our stance clear on the preservation of safety and security for officers and community alike. Now you need to contact your legislators and reinforce this message...*Savings can be found in ways that don't threaten safety and consideration of those ideas must come first!*

CARBON MONOXIDE LEAK AT ALGER

Staff did a fantastic job of identifying and handling a carbon monoxide leak in the Pine unit at Alger on May 17, 2010.

The toxic gas leak required the entire unit to be evacuated to the yard for the better part of the afternoon while the source of the leak was identified and the unit ventilated properly.

Once the unit was cleared to have prisoners return, staff conducted constant monitoring of the air quality until new boiler units could be installed.

BUDGET SHORTFALLS AND CUTS LIKELY

The House and Senate Fiscal Agencies released their estimates this week and they reflect an expected general fund shortfall in the current fiscal year budget of between \$300M and \$500M. A revenue estimating conference today in Lansing will likely narrow those numbers.

Less than expected tax collections from businesses are the culprit, however part of the shortfall (\$250M) could be offset by greater than expected revenues from sales tax. The state will have to decide if those funds should be applied to the current shortfall, or used to address projected shortfalls in the fiscal year that starts October 1.

As we alerted you yesterday, the Department's portion of the shortfall is approximately \$48M and because of the limited time left before the end of the fiscal year, cuts will need to be made quickly in order to achieve the necessary savings.

OFFICERS INJURED IN FIGHTS

Two separate fights at Bellamy Creek on May 17th, led to 3 officers injured, one of whom is still off of work.

The first fight occurred on the walkway during 1st shift and 2 inmates were sent to Seg.

The second fight happened on 2nd shift when the Level IV's were returning from chow. At least 9 inmates were involved in this one and one used a shank to stick an inmate 2 times. It took more than a dozen officers to break up the fight.

As reported last week, IBC was locked down at the end of April for two days and a shake down netted more than 75 metal rods and shanks. Since then they have recovered an additional 30+ metal rods and 4 big pieces of metal from the facility.

FIGHT AND RETALIATION **OFFICER** ASSAULTED AT BELLAMY CREEK

Two inmates in 4 block got into a fight the morning of May 25, 2010. One of the inmates involved was stuck at least 3 times.

A retaliatory fight broke out during noon chow that day, this time between four inmates. It took officers nearly 5 minutes to get the chow hall fight under control.

MAJOR DRUG BUST AT **MTU**

In the morning hours of May 22nd, an inmate bolted from an officer when he was approached for a shakedown. The inmate was caught and restrained and found to have 4 bic lighters, 2 small pipes, 2 camera phones with chargers, 21 bags of tobacco, 24 bags of a green leafy substance, 10 bags of assorted pills, 19 bags of a white powder and 9 bags of a brown times on the 3-11 shift yesterday. substance on his person.

The contraband had been cleverly concealed inside four children's sized soccer balls that had been covered in grass so that they would blend in to the yard. Presumably they were thrown

over the fence during the night.

An officer at Baraga Max was assaulted on Monday when an inmate walking back from breakfast chow turned and charged at him, trying to land a few punches. The inmate was sent to Seg.

Right after this incident there was another fight on the walk, this time between 2 prisoner kitchen workers.

INMATE AIRLIFTED

An inmate from the St. Louis Correctional Facility was housed in a Saginaw hospital earlier this week after being attacked in the head with a lock-in-a-sock, then hit in the head with a television, and then stabbed 11 times.

hospital supervision.

STABBINGS AT KINROSS

An inmate was stabbed 16 Further, the Maintenance building was broken into and a fight broke out in F-unit. The unit was shaken down and a shank recovered.

In another incident earlier this week one inmate beat another inmate with a broom, and then stabbed him with the broken broom handle. The inmate may have lost an eye, sustained multiple wounds and is still hospitalized under special care.

HOUSE DOC BUDGET MOVES...

The House DOC budget moved out of the Appropriations Subcommittee on Corrections to the full House on June 2, 2010.

The budget includes savings from consolidating the three DOC administrative regions into two. It also rejects an earlier proposal for "good time" credits, and \$59.2M in operating cuts that were included in the Senate version.

Representative John Proos (R-St. Joseph) introduced 8 amendments representing cuts to 1)lower per prisoner costs, 2) cut \$68M in increases for economics, 3) eliminate \$46.6M in pay increases for employees, 4) cut 10% from Central Office, 5)\$10M from prison food service, 6) reducing transportation by \$3.5M, 7) cut \$9.9M out of prisoner pay, and finally 8) reduce DOC overtime costs by \$60M. All amendments failed along party lines. The House adjourned on Wednesday, however, without voting.

DOC BUDGET PASSES HOUSE

The Corrections Budget passed out of the full House 63-44 on Wednesday, June 9th, along party lines with the exception that Rep. Fred Miller (D-Mt. Clemens) joined the Republicans in voting "NO."

The House bill differs from both the Senate bill and the Executive budget in several areas. The Senate failed to adopt the House version, so it will now go to Conference Committee where parties from both the House and Senate will work to reconcile the differences.

Key changes in the House bill of note:

- -DOES NOT seek savings through the reduction of inmates through "good time" credits.
- -DOES fund the 3% raise. (Senate version did not).
- -DOES fund SAI bootcamp (Senate version did not).
- -DOES include savings from consolidation of Regions from three to two.
- -DOES include savings from closing the towers at Ryan and Mound.
- -DOES include funds to train 100 new officers. (Senate and Executive versions funded 305 new officers.)

DILLON PUSHES TO PASS RETIREMENT BILL

House Speaker Andy Dillon has renewed efforts to pass SB1227- a retirement plan for state employees. He's advocating it be adjusted to basically mirror the plan recently passed for teachers.

Contraband Intercepted

DOC CLOSES UNSECURED LEVEL I

Officers at Alger found a cell phone, cell phone battery, and heroine inside a prisoners typewriter cartridge on May 24, 2010.

In another incident an alert officer at Carson City observed a suspected transfer of contraband to a prisoner during a family visit. When approached and asked to open his fist, it revealed his brother had handed him five balloons of heroine.

MCO has been notified that the Department of Corrections will be closing the Unsecured Level 1 Housing Unit at the Brooks Correctional Facility effective June 25, 2010.

There are currently 120 prisoners in the unit, however there are 251 Unsecure Level 1 beds open. Indications are that there will be minimal impact on the officers assigned to those facilities.

CTO ARBITRATION WIN

Karen Mazzolini, Labor Relations Representative

MCO won a recent Arbitration regarding Administrative Leave (Article 16, Section G) as it relates to shortened non-duty time between shifts resulting from "work-in-progress" overtime. Certain facilities have handled this by granting the officer admin. leave for the start of their next scheduled shift so that they can have at least 8 hours non-duty time between shifts, while other facilities have allowed the officers to use annual/comp. time instead.

The Department unilaterally ceased to grant leave time in these situations despite contract language that states this process can only be altered through secondary negotiations. The Employer was aware of the secondary negotiation requirement as it has

tried, unsuccessfully, to do so since 2004.

In a June 5, 2010, decision, Arbitrator Dettman sustained the grievance and granted the remedy requested; that those facilities that previously granted administrative leave to employees in these situations from the beginning of the upcoming shift reinstate the process unless altered through secondary negotiations.



TOWERS TO CLOSE

Effective this Sunday, June 20, 2010, the gun towers at the Mound and Ryan Correctional Facilities will close.

MCO has reached out to the media extensively since this was first suggested in late May, appearing on several radio programs and FoxDetroit TV & Ch. 7, as well as contacting legislators, including Senator Buzz Thomas.

Not only do the towers serve as a deterrent, but they maintain peace and prevent contraband from being thrown over the fence. Assault on PRISONER TO AVOID DEBT?

On May 13th an inmate was observed walking up on another inmate and striking him with a closed fist in the back of his head causing him to fall to the floor. He then jumped down on top of the inmate and struck him in the side of his body with a closed fist. The attacker was restrained and sent to Seg. for Assault and Battery.

When officers went to his cell to pack up his property, all of it was neatly folded and placed on the bed ready to be moved. It is believed that he owed several dollars worth of store goods to multiple inmates in the unit and appears that he may have intentionally assaulted the inmate to get moved to avoid his debt.

GUBERNATORIAL CANDIDATE PUSHES TO CUT STATE EMPLOYEE PAY

Republican Gubernatorial Candidate Oakland County Sheriff Mike Bouchard has proposed a constitutional amendment that would tie state employee wages and benefits to no more than 3% above the equivalent private sector job.

Other key items in Bouchard's "Blueprint for Prosperity" include:

-move public employees into a defined contribution retirement plan.

-move public employees to a cafeteria style health care plan, with benefits comparable to the private sector.

Employees would have to pay more for enhanced options or choose reduced coverage.

Bouchard's stated goal is that "Every agency will be scrutinized with the purpose of eliminating wasteful spending with the ultimate goal of getting a larger percentage of funds to the critical impact point of the core mission, such as a teacher in the classroom, health care services to those with low incomes and seniors, law enforcement on the streets and correction officers on the blocks."

STICKERS AT BARAGA MAX PEPPERBALL USED 2X IN Alert officers at Baraga Max 1 DAY AT URF

observed an inmate passing two "stickers" to another prisoner. When searched, they found he had fashioned a pouch in his waistband to conceal the weapons.

On June 16th a CSC prisoner was being escorted to psych when the officer noticed something was not right with the inmate's uniform. A strip search revealed that he had a weapon concealed upon his body.

The weapons appear to be crafted from duffel bag zipper pulls stuck on Seg. pens.

A prisoner in the Level II housing unit refused to exit the B-wing bathroom. After ignoring repeated orders to lay on the floor to be restrained, officers used several rounds of pepperballs and then spray chemical agents before he finally complied.

Later, a prisoner refused to exit the quiet room and was threatening staff with a microwave. He, too, ignored multiple orders to lay down and spray chemical agents and finally the pepperball launcher was used to gain control.

A Letter of Intent between MCO and OSE was signed this week to allow members to comp a portion of overtime even if they are close to the 200 hour limit. Although the current contract prohibits a member from splitting overtime between pay and comp time, this agreement will allow an exception so the member can reach the 200 hour cap and receive actual overtime pay for the balance.

ALGER CRITICALS

Over the span of two and a half weeks, 18 inmates were sent to Segregation for charges including fighting, refusing to lock up, dangerous contraband, being drunk, disruptive and threatening, threatening behavior towards staff, and assault on staff.

During the week of June 18th, 12 were sent to Seg. Once again, the charges included dangerous contraband, refusing to lock up, fighting, threatening behavior, and one sexual deviant behavior towards a female officer.

During routine cell searches staff found 40 cigarettes, mail room staff intercepted heroin in incoming mail, and a weapon was found in the Spruce Unit small vard.

ESCAPE AT KINROSS

1 INMATE DOWN, 2 SURRENDER

Preliminary reports this morning are that 3 inmates at the Kinross Correctional Facility overpowered a MSI semi driver and drove the semi through the perimeter fence.

One inmate then took off on foot and was subsequently shot and killed. The other two inmates laid down and surrendered.

Stay tuned, we will update as soon as we have more information. MCO President Tylutki is en-route.





INMATE SHOT IN ESCAPE AT KINROSS

Three Level II inmates attempted to escape from Kinross yesterday morning by hijacking a MSI semi truck, beating up the driver, and driving through both perimeter fences. The inmates all exited the truck once past the perimeter and began running. One inmate, Seth Privacky, ignored orders to halt and was fatally shot. The other two inmates surrendered.

Prisoner Privacky was serving a life sentence for the 1998 execution-style murders of his parents, grandfather, brother and brother's girlfriend. The other two inmates were also convicted murderers.

The MSI truck driver is being treated for non life-threatening injures.

Staff at Kinross handled this incident professionally as they are trained to do when presented with such a threat to public safety. Kuddos for a tough job well done.

MCO President Tylutki and Vice President Potter are at the facility meeting with the officers involved at this time.

July 4th Fight Leaves 6 Officers Injured

The Alger facility was locked down for more than a day after a July 4th fight left 6 officers injured.

Two inmates were sent to Seg. for assault on staff, 1 for threatening behavior, and 1 for failure to disperse. Further, one of the inmates involved in the original assault on staff kicked and spit on staff during his escort to Seg.

One officer received stitches for cuts on chin, forehead, nose and sustained a back injury, another officer injured his knee, another has a broken thumb in two places, two officers sustained back injuries and the sixth officer was exposed after the prisoner spit into his mouth.

Subsequent shake downs of 5 cells in each unit, yards, food service and all common areas found 4 gallons of spud juice and one altered razor.



Marquette - Fight on Level V yard, August 3, 2010, with 7 prisoners throwing punches. One inmate lost two teeth, and one officer was treated at the local hospital for blood exposure. A second fight broke out the next day during noon chow. Three fights broke out simultaneously in the chow hall. It is believed to be gang related and a continuation of the previous day's incident.

DOWNSTATE NEWS

Forensic Center - A "patient" jumped over the small yard fence and began to climb the outside fence the morning of August 10, 2010. When multiple staff responded the inmate dropped off the fence and began to run, however he was quickly restrained.

St. Louis - A fight between 5 inmates on the inner walk July 31st resulted in one prisoner with a broken jaw, and 2 officers and one Sergeant sent to the hospital with wrist, ankle and back injuries. Another fight on August 4th sent 3 inmates to Seg., and a fight on August 9th (also on inner walk) sent 2 officers to the hospital one with a possible torn bicep.

Carson City - A July 22, 2010, routine pat search found an object on a prisoner inside his shirt. Inmate said it was a broken pen and appeared to throw it away. Officer was suspicious and asked to see the pen. When the inmate went to retrieve the pen from the trash, a 5" piece of sharpened metal fell out of his pant leg.

Saginaw - Two officers sent to hospital on August 6, 2010, after a 5 inmate fight. One officer was punched in the face and the other had a hand injury.

Cotton - Inmate fights shakedown, resists and assaults staff on August 6, 2010. When stripped, it was found to be over a chicken patty sandwich!

You must register for miAccount by August 31, 2010

If you are a member of the Defined Benefit* retirement plan you must register for miAccount by August 31, 2010.

Starting this fall, miAccount will be the primary tool for conducting business transactions with the ACCOUNT

Office of Retirement Services (ORS). You will use miAccount to check your wage and service totals, change personal information, run pension estimates, and when the time comes, apply for retirement.

To register, locate your Member ID (found on the member account access card

that was mailed to your home in early August), visit www.michigan.gov/orsmiaccount, click on the 'State Employees Retirement System' option, and then click 'Register Now' and follow the prompts.

There are computer kiosks at each Human Resources (HR) office that you can use to access miAccount. Libraries and Michigan Works! Service Centers also have internet access available.

Your HR office can help find resources specific to your area.

A tutorial is provided on the miAccount login page that will walk you through the activation process. A secure Message Board (located on the miAccount login screen) will put you in contact with an ORS representative in less than 24 hours.

Need more help? ORS can assist you from 7 a.m. to 5 p.m. Monday though Friday, until August 31. You can contact them at 322-5103 from the Lansing area, or toll-free at (800) 381-5111.

* If you began employment with the State of Michigan before March 31, 1997, you are a member of the Defined Benefit retirement plan.

CRITICAL NEWS

Cotton - Officer assaulted while making a drug bust. Inmate bolted and ran to flush cocaine when approached for a urine drop. Officer responded and tried to stop him but inmate took out his knee.

Mid Michigan 6.28 - 7.19 - 22 gallons plus 10 bottles of spud juice recovered, multiple shanks and 25 - 3" nails found, inmates with dangerous contraband and marijuana, and an inmate assault.

Mid Michigan 7.23-8.18 - one inmate charged with threatening behavior on staff, inmate assaulted while sleeping, dangerous contraband found taped under desk, 7.5" shank found in a shoe, dangerous contraband and tobacco found on inmates, 9.5" shank found in E-Unit, 20 ft. of rope and duct tape found in E-Unit, inmate stabbed in face and taken to the hospital, inmate assaulted and taken to hospital for head injury, 3 foot piece of broken broom handle found in G-Unit.

Alger 8.10-8.22 - Officer assaulted in Seg. when retrieving law books, 1 to Seg. for sexual deviant behavior during showers, 22 to Seg. for fighting/threatening behavior/refusal to lock up, 1 to Seg. for 7" shank on person, 1 to Seg. for assaulting an officer through food slot, 1 to Seg. for masturbating when exiting cell for call out and then assaulted female officer when she tried to close his cell door, 1 to Seg. for assault on staff after punching officer in head, 1 to Seg. for assault on staff when they tried to close his cell door, and more!





CRITICALS OF NOTE

Forensic 8.28 - "patient" gets agitated and begins running around tearing up magazines from library, etc. When an officer approached him to calm him down the patient wielded a 7" sharpened toothbrush shank and stated "Come on, I'm gonna kill someone." Three officers responded and one was sliced by the shank and treated and released from the hospital.

St. Louis 8.31 - A fight broke out in Unit 3 big yard. Staff responded and took two prisoners to be shook down. One inmate had a shank hidden in his shoe. Later, at count, a prisoner told staff that he was stabbed on the yard. He was found to have 3 puncture wounds. Video footage confirmed the attack and the weapon was recovered from a garbage can in front of Unit 3.

Parnall 9.4 - a group of approximately 12 inmates gathered on the yard in front of 9 block about 9 a.m. and began fighting. Nearly 20 officers responded and secured the group successfully, without injury despite the recovery of a very large shank. It is believed to be a hit attempt between gangs. Yard was cancelled and the facility was locked down until 6 that evening.

Alger 8.23-9.5 - On August 31, 2010, an officer was treated and released for shortness of breath and rib cage pain after getting struck while breaking up a fight between two prisoners returning from unit small yard. One prisoner had a weapon and stabbed the other 4 times. Over the two week period, 20 inmates went to Seg. for threatening behavior on staff, possession of weapons including one hidden on a wheelchair, fighting, assault on another inmate, and three for sexually deviant behavior including exposure to a teacher and masturbating at a female officer during his shower.

Over the weekend an inmate came up behind the officer and stabbed him through the ear lobe and again in the neck. After gluing his ear back together, the officer is back on the job!

STATE EMPLOYEE RETIREMENT BILL PASSES IN LATE NIGHT SESSION

Late last night the State Employee Retirement Bill (SB1226) passed the House 60-45 and the Senate 20-14.

Key points to plan:

- 1. 1.6% multiplier for those at least 55 with 30 years or more service who retire between 11.1.10 1.1.11.
- 1.55% multiplier for those not currently eligible but who have a combined years and age of service equal to an "80 and out" provision, OR those who have a straight 30 years of service regardless of age.
- 3. All remaining employees contribute 3% of their pay to a retiree health care account for a period of 3 years. It will then sunset unless taken back up by the new legislature/ administration.

This retirement plan applies to classified civil service employees, unclassified State employees, legislative and judicial branch employees **and covered employees.** The state plans to replace 2 of every 3 who retire, and overall savings are estimated to be \$80M for FY '10-11. A covered employee can retire under the current covered retirement OR the above enhancement, not both.

DOC BUDGET FINALIZED

The FY 2010-2011 budget for the DOC (SB 1153) was passed on Wednesday and is now before the Governor for her approval.

While the budget does not call specifically for the closure of any facilities, the Department has been given flexibility to finding \$42.1M in savings. The DOC has indicated that they do not know how they will achieve the necessary savings, be it from reductions at all facilities, or through actual prison closures.

The budget also assumes savings from the following:

- ⇒ \$5.3M by reducing from 3 to 2 Regions and subsequent loss of 54 FTE's
- ⇒ \$1.8M from reduced gun tower staffing at Mound and Ryan
- ➡ \$6.5M from Transportation Supply chain
- ➡ \$7.6M from Food Service Supply Chain

Officers Injured in Fight at Baraga Max

A fight between two inmates expanded as two more jumped into the fray. Officers responded and broke up the fight but two were sent to the hospital - one took a blow to the head, and the other sustained lacerations to his hand.

Officer Injured at Kinross

When an officer asked an inmate for his ID card at count time the prisoner punched him, smashing his glasses into his face. The officer sustained lacerations and had protrusive swelling of and around his right eye.

The officer stayed on the unit and continued his work.

SICK LEAVE USE/OT REDUCTION

PILOT PROGRAM RECAP

The attendance incentive and physical fitness incentive for the time period of October 1, 2009 – March 31, 2010 is one half of the payment for a fiscal year based upon one half of the sick leave utilization permitted in a fiscal year.

For example: Under the regular attendance incentive contractual language an individual would get \$400 if no sick leave was used during the year. Because we are dealing with a 6-month time frame of October-March, a qualified individual would receive half of the incentive which is \$200. As for the physical fitness incentive payment under the regular terms of the contract an individual who used no sick leave and meets the physical performance standards would be eligible to receive \$300. Again, since we're working with a 6-month time frame that would be cut in half and a member would receive \$150. So, this October a person who has used no sick leave and qualifies for the physical fitness incentive would receive \$350.

The sick leave pilot program is effective April 4, 2010-April 2, 2011. If the pilot is deemed to be successful, an eligible member may cash in up to 50% of the sick leave hours accumulated during the pilot period at the employee's base rate of pay as of April 2, 2011. The maximum a member accrues during the fiscal year is 104 hours, so one could receive payment for up to 52 hours.

If the pilot program is determined to be unsuccessful (determination made in April 2011), then the other half of the payment as described in the example in paragraph #2 above would be paid for the time frame of April 2010-September 30, 2010. This payment can be expected within a couple of pay periods of April 2011. (The member would NOT need to take the physical fitness test again.)

Additionally, if the pilot is unsuccessful it would have no bearing on the incentive payments for fiscal year 2010-2011, as we would revert to the current contract. The six months of April to October 2010 stand alone.

For instance, a member e-mailed MCO and said: So if the pilot is successful we would get to cash in 52 hours minus the \$200 and should still receive the additional \$150 for the physical incentive? Or the entire \$350 would be subtracted? I guess what I am asking is, is the physical incentive separate from the sick leave as it has always been – or have they been combined in the pilot?

Response: If the pilot is successful you wouldn't get the 2nd half of the attendance incentive and physical incentive, you'd have the ability to cash in up to 52 hours of sick leave. There is nothing to subtract out. Per article 37, the maximum you could earn in incentives for perfect attendance and physical incentive is \$700. (\$400 for S/L and \$300 for physical) A person earning \$24.27 per hour could get \$1262.04 by cashing in 52 hours under the pilot. That is the benefit if the pilot is a success. Additionally, the payment received for the time period of Oct 1, 2009-March 31, 2010 would have also been paid.





Officer Beaten at MR

On Wednesday night a call went out over the radios at MR for help. A responding officer found an inmate sitting on the floor in the hall, about 20 feet from the bulkhead door, with his legs wrapped around the waist of an officer. He had secured the officers upper body with his right arm, and was beating the officer in the head with his left.

It took a few minutes for staff to key through the door (not all officers have a key to the bulkhead door) and get to him, however when the did the inmate was subdued quickly. The officer sustained substantial injuries to his head and face, lost a tooth, and was bleeding from his ears.

When officers put the inmate in the showers to cool down he said "I will, I already did what I had to." It is believed that this was all done over a contraband radio that the officer had confiscated from the prisoner.

PA INMATES A DIFFERENT BREED

MCO Officials met in Muskegon this week to tour, talk with management, and view footage of recent incidents at the facility.

One incident occurred when an inmate came out swinging at officers from his cell, landing the officers on the floor in the hall. A group of 40-50 prisoners gathered around and ignored orders to disperse. While officers were trying to restrain the inmate, prisoners standing around started pulling officers off of the pileinterfering with their ability to do their job.

Fights broke out simultaneously in the chow and yard with dozens of inmates each on Monday Sept. 20th. Then on Tuesday, inmates barricaded the bathroom shut while they beat up a prisoner inside. The prisoner ended up with his throat slashed and required stitches. Several officers received injures as a result of breaking things up.

Many of the fights are believed to be rival "turfs" back in PA, as well as debts owed by inmates transferring back to the state.

ALGER INCIDENTS

During the two weeks of September 8 - 21st, there were 7 inmates to Seg. for threatening behavior, 4 for sexually deviant behavior, 1 for dangerous contraband, 6 for refusing to lock up and 4 for fighting. Additionally, one inmate was charged with sexual assault on a female doctor on September 13th, and another inmate with assault on staff on September 19th.

From September 25 - October 4th, there were 10 prisoners sent to Seg. for fighting, 2 for threatening behavior, 2 for refusing to lock up, 2 for threatening behavior, 1 for dangerous contraband, 2 for possession of a weapon and more. Further, an officer injured in breaking up a fight on September 28th is still off of work. Also on the 28th officers found 14 packets of marijuana on an inmate, and on the 29th found 5 gallons of spud juice on another.

PROTEST AT MR

On Wednesday, a group of 35-40 Level II inmates marched on the yard in a protest believed to be over the restricted movement initiated after the assault on an officer last week.





EARLY RETIREMENT ENHANCEMENT REVIEW

We have been getting a lot of questions regarding the State Employee Retirement Enhancement that was recently passed by the legislature. First and foremost, please consult the Office of Retirement Services and seek the advice of a retirement specialist before making a decision. The following information is provided merely as a clarification of things as we understand them at this time. Ultimately this is all in the hands of the ORS and thus their counsel on your individual retirement situation is advised.

As covered employees, COs under the Defined Benefit Plan have a Supplemental Retirement that is available if they meet the eligibility requirements. Under this Supplemental Retirement, eligible officers can retire with a 2% multiplier until they reach age 62 at which point it drops to 1.5%.

SB1226, now officially known as Public Act 185, offers the following Early Retirement Enhancement options:

- 1.6% multiplier for those at least 55 with 30 years or more service
- 1.55% multiplier for those not currently eligible but who have a combined years and age of service equal to an "80 and out" provision
- 1.55% for those who have a straight 30 years of service regardless of age

Much confusion has surrounded how PA 185 relates to covered employees who have the Supplemental Covered Retirement. The Office of Retirement Services has stated that if eligible, you can retire under one or the other, BUT NOT BOTH. Thus, you *may not* retire now and receive the 2% multiplier until age 62, and then have it revert to the 1.55% or 1.6% that is in the new legislation.

Another question some have asked relates to "buying time" to become eligible to retire. You are allowed to purchase time, but it must be paid in full before your actual retirement. ORS will work with you on payment options, including such things as a rollover from your 401(k) among others. However, covered employees cannot buy time to count towards the Supplemental Retirement. Time purchase only counts toward regular state retirement.

Finally, to remind everyone, all state employees working after November 1, 2010, will have 3% of their wages deducted (including overtime). The deduction will be "pre-tax" so it will have the practical effect of a little less than 3% - but it is still a terrible hit. MCO and most other state employee unions have joined together and are preparing a legal suit against the state regarding the 3% hit. Stay tuned...





ELECTION TURNS TABLES IN LANSING

Tuesday's elections not only brought a lot of new faces to Lansing due to term limits, but it also resulted in a turnover of many seats to Republican hands.

The Governor, Attorney General, Secretary of State, and Supreme Court landed Republican. The House turned over to a Republican majority with a 64/46 split. The Senate increased its Republican majority to a 26/12 split.

MCO will be reaching out to all new lawmakers, regardless of party, when they hit the Capitol in January. We plan to work hard at educating these new faces on corrections and what it is really like to work behind the walls. We'll need your help so stay tuned for events in your area after the start of the new year.

3% DEDUCTION STARTS THIS PAY

If you log in to see your pay stub today you will see that the 3% deduction for the health care trust starts this paycheck. MCO and the State Employee Union Coalition is filing a lawsuit against the state on this matter and are in the process of filing a ULP as well.

ANNUAL LEAVE HOURS FOR ELECTION HOLIDAY

On Tuesday state employees had a holiday. Because Corrections is a 24 hour operation, we obviously cannot shut down for such an event. In light of this, MCO negotiated into our contract that COs receive 4 hours of annual leave each year added to your bank to compensate for the 8 hours every other year that other state employees receive on Election day. The additional 4 hours should appear on your next pay stub.

DRUG ODS AT SAGINAW?

An inmate in the Level II housing unit at Saginaw died on November 9th. The inmate was found unresponsive, but breathing, however he went into cardiac arrest and was pronounced dead at a local hospital. A search of his cell located a syringe which leads to the belief that it was the result of a drug overdose. It will, however, take several weeks for the toxicology results to come in.

Just two days earlier a Level IV inmate was also found unconscious, however he was taken to the hospital where he responded to treatment administered for an opiate overdose. A search of his cell also turned up a syringe.

CENTRAL MICHIGAN ON LOCKDOWN

ACADEMY TO START MONDAY

Lansing. These officers are headed to Adrian, Huron Valley Womens, Woodland/Maxey, SAI and Muskegon.

While there are still approximately 35 officers laid off, they were all contacted and offered positions prior to the hiring of this new class.

BALDWIN

The GEO Group has signed a contract with the state of California to bring in up to 2,580 inmates to the "North Lake Correctional Facility" in Baldwin.

GEO GROUP TO RE-OPEN

The facility will be undergoextensive renovation ing and expansion to increase the capacity. Inmates are expected to start arriving in May, 2011.

MCO TALKS WITH

Earlier this week MCO was invited to and met with Governor-elect Snyder's Transition Team on Corrections. MCO Executive Director Mel Grieshaber, President Tom Tylutki, and Vice President Andy Potter met with the transition team, which is headed up by former MDOC Director, Bill Martin.

MCO discussed our views on a wide range of issues in the Department - including waste, doing more with less, finding efficiencies, wages and benefits, staffing, and more. MCO left no stone unturned.

The Transition Team on Corrections will be putting together a report to be submitted to Governor-elect Snyder in the coming weeks so that he can be prepared to hit the ground running with his inauguration in January.

MCO FILES SUIT

On Wednesday Nov. 10th, MCO filed suit in Ingham county over the 3% reduction of state employee wages that was incorporated into the Early Retirement legislation (PA 185). Other state employee unions have filed suits as well, including AFSCME, UAW, SEIU 517M, and MSEA.

The suit charges that the deduction of 3% in this manner constitutes violations of several Articles of the Michigan Constitution, the US Constitution, and the 5th Amendment among others.

MCO is seeking a preliminary injunction ordering the state to hold the monies collected after Nov. 1st in an escrow account pending the outcome of the case. Further, MCO is asking for a declaratory ruling and judgement that section 35 of the Retirement Act is illegal and unconstitutional and that all members compensation be returned with statutory interest.



Officer Henry Underwood, 45, of the Ryan Correctional Facility, passed away on Nov. 18, 2010, after a prolonged illness.

MCO TAKES NEXT STEP... **ULP** FILED

MCO officially filed an Unfair Labor Practice charge against the State of Michigan, Office of the State Employer, on November 30, 2010.

The ULP charges that the implementation of the 3% levy on employee wages for retiree health care by the OSE constitutes a "Refusal to Bargain in Good Faith." Compensation, and any withholding thereof, is a mandatory subject of bargaining and thus any levy imposed outside of contract negotiations is a violation of Civil Service Rules.

MCO is requesting a cease and desist on any new withholdings and that employees are to be made whole, among others.

As reported previously, MCO along with the State Employee Union Coalition, filed lawsuits last month on this issue as well because it is a violation of the Michigan and Federal Constitution. The 3% levy was part of the Early Retirement bill that the legislature passed in October and was enacted as PA185. The first court date for the lawsuits will occur next week.

UNION SECURES INJUNCTION ON 3% WAGE LEVY

Judge William Collette heard arguments last week on the requests for preliminary injunctive relief filed by SEIU Locals 517M and MCO (526M), and by UAW, Local 6000, AFSCME and MSEA. He granted the injunction requested by the unions and ordered that the 3% being deducted from state employees' pay be held in an escrow account pending a final decision in the cases. We argued that the Michigan constitution gives the Civil Service Commission exclusive jurisdiction over the compensation and other conditions of employment of state employees and that the legislature has no authority to change our compensation. Judge Collette agreed with us and held that we are likely to prevail on this argument. He also stated that he thought that the employees could be irreparably injured if the injunction did not issue because he doubted that the legislature would appropriate the money to pay them back if the unions won.

This is just the first round in this case but we are very pleased and encouraged that the court held that the state cannot solve its financial problems by violating the constitution and taking money from state employees to pay its bills. We expect that motions for summary disposition will be filed in early January and decided in February.

MCO VICE PRESIDENT TO CHAIR SEIU NATIONAL REPUBLICAN COMMITTEE

4 OFFICERS ASSAULTED WITH URINE AT EGELER

On December 5, 2010, an officer entered and attempted to remove a urinal from the cell of an inmate on top of bed flex restraints. The inmate was able to splash the urine on the officer's face, shoulder and chest. Three other officers were also splashed in the face.

When officers exited the cell to notify shift command the inmate slipped his restraints, removed the IV pump from the pole and began to use the IV pole to punch holes in the dry wall.

Officers were given an exposure control packet and sent to Allegiance Hospital for evaluation and treatment.

Allegiance Health Secure Unit Inmate Assaults Officers

On December 11, 2010, when an officer and a RN entered the room of an inmate they found he had removed the soft Posey restraint from one wrist and was standing up. The inmate refused orders to sit down and became agitated and began yelling.

When another officer entered the room the inmate removed the remaining restraint and attempted to exit the room. The inmate removed the foot board from the other bed and tried to strike the officer with it. The inmate we have a we have a state and and the based and

it. The inmate was subdued with a radial stun to drop the board and taken to the floor.

Three Allegiance Security Officers assisted in restraining the inmate. The inmate's continued agitation resulted in four point restraints and a chest strap while medication was administered to calm him down.

When back up officers from the facility arrived the two officers were sent to the ER where one was treated for multiple scratches and a bruised wrist, and the other sustained a fractured wrist.
