Michigan Corrections Organization Government Affairs Report – Jeremy Tripp

### Political

- Member Driven Political Process MCO continues its multi-pronged approach to building relationships with legislators and prospective candidates. Meetings have been held with candidates on both sides of the aisle and will continue as the political season goes into high gear.
- Time to Build— Over the next few months, MCO will embark on an aggressive agenda to meet and discuss our issues with key candidates and elected all across Michigan. Examples of upcoming events (Town Halls, Small Groups, Focus Groups, Candidate Screenings)

# Legislative

• Targeting (HB4585,4590,4591) - Separate Crime for Targeting Victim Based on Employment

House Bills 4585 and 4590 would amend the Michigan Penal Code (MPC) by adding new sections that would create additional felonies for targeting a victim based on his or her actual or perceived employment. House Bill 4591 would amend the Code of Criminal Procedure by creating sentencing guidelines to accompany the newly proposed felony offenses. The proposed felonies would be punishable by imprisonment for not more than two years and would have to be served consecutively with (either before or after, rather than concurrently) any other term of imprisonment imposed for the underlying felony or attempted felony.

Reported with recommendation on 10/3/2017 and referred to second reading

Drone Bill (HB4248) & DRAFT Legislation

HB4248 would prohibit intentionally and knowingly operating an unmanned aerial vehicle within 1,000 feet of a correctional facility.

Referred to Committee on Communications and Technology on 2

**Draft Legislation** – Would prohibit and provide penalties for knowingly operating an unmanned aircraft or flying the aircraft in a manner that interferes with the operation of a correctional facility or county jail.

# Corrections Security Representative (CSR) – DRAFT Legislation

This legislation would correct the removal of CSR's from covered service. This was done based on an Auditor General report which recommended several classifications for removal.

# Member Growth and Retention

MCO remains top in state government with 97.5 % of corrections officers and forensic security assistants choosing to belong to the union.

Over the several years we have maintained momentum at the academy level and our innovation is being recognized nationwide as the gold standard for new member organizing.
