#### State Vehicle Mileage Rate Increases

The State Rate for Private Vehicle usage was increased from 37.5 cents per mile to 40.5 cents per mile effective January 1, 2005.

This change is the result of an increase in the Federal Standard Mileage Rate by the IRS, which is what governs the State of Michigan rates.

A physical confrontation between three prisoners in the rec yard at MTU in mid-November involved the use of a lock-in-asock as well as a shank.

Two officers took a prisoner to the ground in a bear hug maneuver and placed him in cuffs, but not before the individual was able to kick another inmate in the back and punch one of the Officers in the head.


The third officer restrained another inmate who had fled the scene. This individual had been observed hitting another inmate with the lock-in-a-sock

A shank was then found on the third inmate involved in the altercation.

At shift change there was a systematic shake down of all prisoners and of the yard in an effort to locate additional weapons.

One prisoner involved required medical attention at a local hospital, and the three officers were treated for minor blood exposure.

# Assault at Mound on January 25, 2005

After a CO radioed for assistance to "take one to the hole" she was struck several times with a closed fist by the inmate who refused to comply with orders.

Responding officers took the prisoner to the ground and restrained him. They found the Officer face down, unresponsive, and bleeding severely from the facial area.

After treatment at the local hospital the officer was released with contusions, lacerations and a possible broken wrist.

## Officers Injured While Breaking Up Fight

A brawl on January 28th, at HVM resulted in four officers being sent to the ER for treatment.

It all started when two prisoners started fighting in the 5 block dayroom. Officers responded immediately and sustained lacerations and contusions while attempting to separate and restrain the two inmates. In the process of breaking up the fight, another inmate joined the melee and swung punches at one of the inmates and the officers restraining him.

## Perimeter Incident at Bellamy Creek

On the morning of January 28th, perimeter officers discovered suspicious footprints leading up to the fence along the big yard at Bellamy Creek. All indications are that contraband was thrown over the fence.

All movement was halted after lunch lines and Housing Unit 4 was shook down, however nothing was found.

## Swift Action by CO's Prevent Injury

Officers at MTU acted quickly and were able to maintain control of 80 prisoners in the card room when a fight broke out between three prisoners. A lockin-a-sock was found after the room was cleared, but had not been able to be used.

# Officers Attacked at Cotton

January 31st proved to be a dangerous day for officers in the TD Unit at Cotton.

After being asked to submit to a pat search, a prisoner began to hit the officer involved about her eyes and face opening a cut down to the bone.

A responding officer, who had been doing a shakedown elsewhere, also took blows to the face resulting in the fracture of his orbital bone and severe lascerations to the face and eye area.

The officers were transported to Foote Hospital where they were treated for their injuries and possible blood borne exposure.

### MCO Protests Diaper Changing Issue

The union continues to argue with the Department of Corrections over its attempts to require Corrections Officers to change diapers of mentally ill prisoners.

MCO's position is that changing diapers will undermine the ability of Corrections Officers to maintain the proper degree of authority and respect needed to manage prisoners.

This is not a direction Corrections should go and we will continue the fight!

# **DOC Plans Closures to Save Money!**

The Department of Corrections announced this morning that Camp Tuscola and Camp Sauble, as well as the Buena Vista and Benton Harbor Centers are scheduled to close in June. In addition, they plan to change Camp Koehler to a Level I facility. Meetings were being held at the affected facilities when the announcements were made.

MCO will be meeting with the DOC to discuss the closures and to ensure that the Union Contract is followed.

There are still many vacancies in the state so no officers will lose their job.

#### Contract with Youth Prison Cancelled!

legislation was passed to allow for a private run youth prison, MCO has lobbied the State against this practice.

In an announcement by Governor Granholm today, the State will be discontinuing its contract with the Youth Prison located near Baldwin, Michigan.

The youth offenders will be brought into the Michigan Prison system within approximately 90 days.

The building is owned and operated by the Geo Group, and there remains the possibility that they could bring in prisoners from other states, federal or immigration prisoners.

#### Several Level I's to increase population

MCO was informed that the DOC plans to increase the number of beds at 10 Level I facilities in the state.

### Forensic Sees Five Criticals Since Nov.

There's been a rash of critical incidents at the Forensic Center, the latest occurring at the "new" Forensic, which opened last week.

In November a patient just off assault precautions attacked a nurse, which resulted in leave for the nurse and four forensic officers.

December started with another attack by a patient with an assaultive record. Before the two officers who'd been attacked could even return from the hospital for treatment of their bites and head injuries, the same patient attacked a doctor, nurse and forensic supervisor while being debriefed. And later that month, an officer sustained ligament and bone damage to his arm while secluding a patient and remains on leave.

In January a female officer was kicked in the stomach by a patient who had a record of attacking women and who apparently believed the officer was pregnant. That officer is still on leave.

On February 10th, a patient sucker punched an officer in the face, causing significant injuries. This officer also remains on leave.

## Michigan Correctional Officer of the Year - 2005



After intense interviews on February 17th, at the Demarse Academy in Lansing, CSR

Ken Hatfield was chosen as the Michigan Department of Corrections 2005 Correctional Officer of the Year!

Officers are selected based on their work ethic, MDOC policy compliance, communication skills and professionalism.

Hatfield has worked for the Department for 9 years, first as a CO, then CSR, RUO, CTO and then again as a CSR in the Absconder Recovery Unit since 2003.

In the past year he has been directly involved in the apprehension of approximately 134 escapees and parole violators.

One apprehension became life threatening when two

absconders exited their vehicle with guns. They then fled into a local restaurant, which was filled with nearly 85 patrons at in the time, taking one hostage. Hatfield took a leadership role by constantly talking to the absconders, and simultaneously helping to get the patrons out of the restaurant safely. The absconder was ultimately shot and taken into custody. Hatfield's professionalism and calm demeanor were critical in managing this situation.

> Ken has established an extensive network with Social Security, Telephone Agencies, the FBI, US Marshals Service and others to conduct the effective "safe street sweep" operation.

Ken also serves as a part time police officer in Portland, MI, and is actively involved in his community Crimestoppers program, giving talks to rescue missions' staff, law enforcement agencies and other community organizations.

March 8th proved to be an eventful evening at the Forensic Center. In two separate incidents, one officer ended up with a broken wrist, and another was bitten. They are both off of work at this time.

One of the incidents was at the hands of a patient who had previously been put in seclusion for an attack on a fellow patient.

#### TRANSPO RUN FROM BAD TO WORSE ...

A run from Duane Waters Hospital to Standish didn't start off well, and ended worse. While at the hospital, the inmate spit striking an officer in the face. The prisoner was placed in a spitters mask, and secured in the van where he began kicking the plexiglass between the seats and ignored orders to stop. Chemical agents became necessary.

On route back to Standish the prisoner spit over the plexiglass in the van, striking the officers on the face and clothing. They stopped the vehicle on two occasions eventually using chemicals again and contacted the MSP. While waiting, the inmate urinated underneath the plexiglass into the front of the van.

With the MSP, the inmate was removed and placed in belly chains, however he spit in the face of a Trooper.

Back at Standish, the prisoner kicked several officers when they placed him in top-of-bed restraints.

### Officer Credited for Critical Prevention

On March 9, 2005, an inmate entered a Level IV unit at Brooks appearing very agitated. An RUO on duty noticed and attempted to question the prisoner, however the inmate refused, ignored orders to stop for a shakedown, and ran to his cell. Officers prevented him from entering his cell. The prisoner then revealed a shank.

The Officers tried to talk the prisoner down, however he bolted into a library/study room and began stabbing an inmate in the back.

#### Prisoner Murdered in Unit with Closed Position

On Saturday, March 19th, inmates from one of the four wings in Unit 3 (a transition unit) at Standish Max were let out of their cells to go to the yard.

Upon release to the yard two prisoners began attacking a third. They knocked him to the ground kicking and stomping his face and head.

Yard officers from other Units responded as quickly as possible, but not before the inmate sustained major trauma to the head and neck.

At the time of the incident, there were only three officers in the unit... 2 RUO's and one CO. There are supposed to be four, however the fourth position was closed that day. One RUO was in the bubble, the other was doing moving to the yard.

Governor Granholm temporarily lost her fight to get rid of the private youth prison contract. A deal has been reached with the Legislature that will balance the fiscal year 2005 budget. The agreement includes Executive Order 2005-7, which was presented to a joint session of the House and Senate Appropriations Committees, passage of the fiscal year 2005 Capital

#### Level IV Fight at MRF

On April 1st, a fight broke out between two Level IV prisoners in the Back Yard. Three C/O's responded and when they arrived one inmate threw a shank over the fence.

The situation was brought under control and thankfully the other Level IV's in the yard chose not to get involved.

At the time of the incident, the fourth CO assigned to the yard had been pulled to do computer work. Ken Hatfield, Michigan's CO of the Year, was selected as one of five Finalists for the International Association of Correctional Officers 2005 CO of the Year Award. He will be traveling to Washington DC at the end of the month for the Awards Ceremonies. Outlay budget bill; and passage of a supplemental appropriations bill which includes portions of the Governor's Jobs Today Initiative.

As you may recall, the Governor's original Executive Order proposed canceling the contract with the Youth Prison in Baldwin. This new agreement, however, prevents the closure for the remainder of this fiscal year.

#### Two Alger Assaults in Three Days

During the 2-10 shift on April 1st, an inmate thrust his arm out of the slot with a weapon and attempted to stab the officer who was passing out mail. The officer was hit in the stomach, but the weapon broke and did not penetrate.

Just two days later, another officer was assaulted while doing a six month move on an inmate. Out of his cell and in restraints, the inmate lowered his shoulder and rammed the officer.

Thankfully no officers were harmed in these events, but this just goes to show that incidents are happening even in our segregation units!

#### Critical at MTU

On the morning of March 28th, information came forward that there were shanks in one of the units. Officers immediately shook down the named inmates and found shanks in the area of 3 inmates, and 3 other inmates were found in possession of them.

While the facility didn't allow a shake down of the entire unit...at least the shanks were found and removed before any harm could be done.

The following day, another shank was found in the same unit, and it was locked down for 24 hours.

During the time the officers were shaking down the rooms of these prisoners, a fight broke out between two inmates in front of another unit. Officers had a tough time handling the fight because they were short positions.

Things don't look good for the summer and this is just the beginning.

## Yard Incident at Gus Harrison

On April 13th, approximately 10 - 15 inmates in the Level IV Yard were involved in a fight while the yard position for that unit was closed. There happened to be three med runs out at the time, thus leaving the shift 5 positions short.

At least one inmate was taken out by ambulence, and several others required treatment.

Once again, we were lucky to not sustain any staff injuries.

### MCO Fights Kinross Staffing Levels

President Tom Tylutki and Executive Director Mel Grieshaber met with RPA MacMeekin and Warden Metris on March 25th to discuss the staffing levels at Kinross in light of the substantial increase in the number of prisoners at the facility.

There is disagreement on the number of positions to be added to maintain the security of the facility which will be nearly 300 prisoners over normal capacity.

This issue is not finalized and will be revisited once all the prisoners have arrived.

#### Critical at Carson City

On March 23rd, an Officer was hit by a prisoner who was resisting his escort from Segregation to Health Services. Thankfully the Officer was not injured in this altercation.

## House Committee Continues to Pursue Prison Privatization

On Tuesday, April 26, the House Appropriations Subcommittee for Corrections held a two-hour hearing on prison privatization. Testifying before the committee, the Geo Group, which owns and runs the private Michigan youth prison, argued it was more cost effective than any other Michigan prison and reviewed its experience across the nation. In addition to the Geo group, the committee heard from the Reason Foundation and the Mackinaw Center. Both organizations are "think tanks" that advocate privatizing governmental services.

Even though several individuals and organizations that oppose private prisons were present at the hearing, the committee chair refused to allow any to speak. Anticipating committee resistance to any opposition, MCO Executive Director Mel

Grieshaber maneuvered his way into testifying last week before the committee. Grieshaber argued that MCO and public correctional officers everywhere are philosophically opposed to private prisons. He added that discontinuing the private youth prison contract would return \$18 million to the state system and help fund the appropriate staffing needed by officers working in the prisons. Some of the verbal exchanges between Grieshaber and one of the more conservative representatives was tense at times.

It is obvious the majority on the committee is very interested in pursing the whole issue of private prisons and service in state government. In addition, comments made over the last few hearings indicated some hostility towards unions.

#### **INMATE HITS FENCE AT RIVERSIDE**



## MCO PUT ON NOTICE

This week, the MDOC informed MCO that it was their intent to move forward and staff housing units at all women's facilities **with female officers only**. The Department is waiting to see if the U.S. Supreme Court is going to hear MCO's appeal. If the court declines to hear the case, or if they uphold the U.S. Sixth Circuit Court of Appeals' decision, the MDOC will proceed with these plans. Any other gender sensitive positions, such as "intake", will be filled by female officers as well.

MCO fought this issue from the beginning, expending hundreds of thousands of dollars in legal costs because we believe "a uniform is a uniform." We won our case at the U.S. District Court level, but lost when it was appealed to the U.S. Sixth Circuit Court of Appeals. The MCO Executive Board decided unanimously to appeal to the U.S. Supreme Court last month.

At this time, there are no other details to share. The MDOC has indicated its willingness to work with MCO to provide as smooth a transition as possible. It could be many months before the Supreme Court will decide if it will hear the case, but MCO thought it important that members working at women's facilities be aware their future may be affected. MCO will keep everyone updated as new information is received.

#### SENIORITY BASED TRANSFER WINDOW

Seniority Based Transfers, administered by the DOC, are available to employees who met the conditions as laid out in Article 15, Part D, Section A, #2, page 79.

The window period to apply is May 1 - May 31, for a transfer that will occur between July 1 and December 31.

The list expires after each window period, thus you need to sign up again if you didn't get a transfer last time.

#### NOTICE:

MCO will be transitioning to the new website from Friday, May 20th to Saturday, May 21st. As a result, there may be some "down time" when you will incur errors attempting to view the site. MCO's web address will not change, however, and the new site should be up and working by Sunday morning.

## BRAWL AND STABBING AT CARSON CITY

On May 9, 2005, a "code blue" was called in the Sports Room of the 900 Unit at Carson City. Two prisoners were observed exchanging blows with fists and a lock on a belt. The inmates ignored orders to break it up, and were eventually restrained, but not without one of them putting up quite a fight.

After the room was secured, officers were notified that there was another inmate in his cell who was bleeding. After inspection in the Health Center it was determined that he had been stabbed by one of the fighting inmates. The inmate was transported to the hospital for treatment and a shank was later found in a unit trash can.

Five officers were treated at the hospital for blood exposure. The two fighting inmates received major misconducts for weapons, assault on staff, and fighting.



# NEWBERRY AND CAMP MANISTIQUE ON SENATE CHOPPING BLOCK

On Thursday, the Senate Appropriations Sub-Committee on Corrections passed a budget for the MDOC that calls for the closure of Newberry and Camp Manistique, all while retaining the contract with the "punk" prison in Baldwin. This, despite the recent Auditor General's report which recommended canceling the contract, and the Senate and House Fiscal Agencies determination that several millions of dollars in savings could be achieved if such an action were to be taken. The decision by Senate Republicans to close Newberry came out of the blue without notification to either the Department or MCO.

The budget also supports the removal of male staff from female housing units at the women's facilities, and eliminating Hepatitis C funding. This bill, Senate Bill 268, reflects a reduction of nearly \$29 million dollars from the Governor's original budget proposal.

# HOUSE BUDGET CLOBBERS CORRECTIONS

Thursday night, the House of Representatives passed an omnibus budget bill that determines funds for every department, including the MDOC and DCH. The MDOC bill retained the private youth prison contract and eliminated funding for the Newberry prison and Camp Manistique. The bill passed on a straight party line vote with every Republican voting for the bill and each Democrat voting against it.

Having been left out of all decisions, Democrats protested the entire process. Even though certain Republicans claimed they were trying to work out a deal to save Newberry, in the end they voted to eliminate the funding. In recent weeks, MCO lobbied aggressively for support and asked all legislators to vote against the bill if it included the private prison and ended funding for Newberry and Manistique. MCO immediately launched a member activism campaign coordinating with local leaders to harness community involvement as well. Legislators acknowledged they had received hundreds of e-mails and phone calls from concerned constituents. Apparently ignoring their input, the majority party moved ahead with its plan to pass a budget that will harm hundreds of working families.

Governor Granholm and the MDOC oppose the private prison and the closing of Newberry and Manistique. They are fighting to save the U.P. facilities and insist the state does not need the private prison. The fight is not over. Next week the Senate is scheduled to vote on all budget bills. MCO will continue to advocate for our members and is asking all members to continue contacting your legislators.

## Senate Passes DOC Budget

The MDOC budget passed the Senate on Wednesday with a straight party-line vote. Every Republican voted for it and every against. Although Democrat Senator Prusi was successful in amending the bill to establish some funding for Newberry, he and the Democrats voted against the budget because it maintained funding for the private prison and other harmful components. The Prusi amendment put \$100 in as a line item to fund Newberry and Camp Manistique. This has the effect of "holding" a place for future discussion. Without the amendment, there would have been no ability to negotiate with the House because the House budget version eliminated all funding for Newberry. Senator Prusi and other legislators convinced the Senate majority leader and Senator Cropsey to hold a hearing regarding the Newberry Committee Chairman issue. Cropsey has scheduled the public meeting for Tuesday, June 21<sup>st</sup> in Lansing.

MCO continues to fight. Closing the private prison will save money according to all reports. Not only does keeping Newberry makes sense, but the MDOC cannot suffer any more cuts to it's budget. Correctional officers are doing "more with less" and safety is of utmost importance.

A press conference was held in Newberry on Wednesday featuring MCO president Tom Tylutki, Chapter president Gary VanSickle and MSEA president Jack L. Yoak, among others. An informational picket is being held Friday at the prison to show support for the Newberry community. MCO members, family and friends should continue contacting legislators in both Houses, especially the members of the Senate Sub-Committee on Corrections (Cropsey, Brown, Garcia, Switalski and Prusi). Senator Cropsey has emphasized the point on numerous occasions that he is abso-

Caruso, when asked by legislators which facility to close, responded that as long as they kept funding the punk prison, "I'm not playing your game."

#### PAPERS FILED!

The lawyers today filed the appeal regarding the genderbased lawsuit to the U.S. Supreme Court. The court will decide at some future date if they will hear this case.

#### INMATE STABBED AT Southern MI

On the afternoon of June 10th, a prisoner was stabbed in the back of the head in a housing unit. One inmate was placed in seclusion for assault causing serious injury, and two more for conspiracy to commit assault.

Alarmingly the unit was not locked down for a search and the weapon was never found. And, despite the fact that a shank had been found earlier in the day in a Level IV unit, the facility operated as usual. Apparently there was no concern of reprisal as the next morning several officers were even pulled off their assignments for training.





#### BRAWL AT THE OAKS LEAVES OFFICER INJURED

As prisoners from housing unit #2 were returning from the morning meal on June 15<sup>th</sup>, a brawl broke out in the commons area between six inmates. Responding officers were able to separate the individuals but not before the Tower officer was forced to chamber a round.

Two shanks were found; one on the ground, and one on an inmate. One officer and an inmate required medical treatment at a local hospital. The officer received a wound to his lower right arm while breaking up the fight and the inmate had a puncture wound to his right eye.

Major Misconducts were written on all six inmates and they were placed in segregation. Reviews of the videotapes showed all officers acted appropriately to break up the fight.

#### MEMBERS FORCED TO STAFF WHV COMPENSATED

As a result of a Letter of Understanding between MCO and the MDOC, those officers from Western Wayne who were forced to staff Huron Valley Womens before transferring to the facility of their choice will be receiving compensation for their mileage to the WHV facility. The Department is currently reviewing and calculating the funds for those eligible and will be making payments in the weeks to come.

#### FIVE OFFICERS SENT TO HOSPITAL FROM STRAITS

On June 16<sup>th</sup>, an inmate, who had worked his way down from a level four, threatened an officer with bodily harm. An ARUS attempted to stop him from attacking the officer when she was grabbed by the wrist and received a blow to her eye. The inmate continued to fight; striking three more officers in the process.

Eventually they were able to place the prisoner in leg irons and belly chains. His behavior, however, remained threatening and the ERT extraction team from URF was called in to take him to the Seg unit at URF.

The five officers who were sent to the hospital were treated and released with minor injuries.

Apparently this inmate had received multiple tickets and accrued 5 points while in secure level one at Coldwater awaiting review of a threatening behavior ticket... which he beat and was then sent to KTF three weeks ago.

### PRIVATIZATION FIGHT TAKES TO THE CAPITOL

On Tuesday, June 21<sup>st</sup>, officers lead by Newberry President Gary VanSickle, MCO officials, Newberry citizens, DOC officials, Legislators and the Governor gathered at the capitol to rally against privatization and the closure of Newberry and Camp Manistique.

# According to the Governor... "This will not pass my desk!"

Later that day they packed the Senate Hearing Room for a special hearing on Newberry before the Sub-committee on Corrections. Along with Newberry officials who testified about the devastation these closures would cause to the UP, Warden Kurt Jones from Carson City testified to the security threat a flat 3% cut to each facility (Rep. Casperson's proposal) would cause. Mel Grieshaber, MCO Executive Director, also testified on the fiscally irresponsible choice of the Legislators to support privatization over more efficient state run facilities.

Discussions will continue as the House and Senate must now resolve the differences in their bills before submitting one to the Governor.





JUNE 28, 2005

The MDOC has formally notified MCO of its intent to immediately place female officers in select positions at all female facilities. The Department won the gender based lawsuit at the Court of Appeals level, however MCO members have made an appeal to the U.S. Supreme Court.

Former MDOC Director, Bill Martin, started moving the Department down this road in 1999 after a series of news stories and legislative hearings.

The current Senate version of next years Corrections budget calls on the MDOC to implement this plan. The Department has indicated it is pursuing an ambitious schedule with completion at Scott within 30 days, followed by WHV within 60 to 90 days, and then Camp Brighten within 90 days.

Details of how such movement of officers will occur are unknown at this time. MCO is reviewing the contract and seeking further legal opinion on the matter. The MCO Executive Board is scheduled to meet next week with this critical issue at the top of the agenda.

# WE MUST CONTINUE THE PRIVATIZATION FIGHT!

Steps were taken this week by the Senate and House to move forward with the Corrections Budget. As the Senate and the House each have different versions, the bill will now go to Conference Committee where they will develop one bill to be proposed to the Governor.

It is critical that we keep the pressure on our legislators and let them know that if anything is to close, it should be the more costly private youth facility in Baldwin. And further, that Newberry and Camp Manistique should remain open.

Last week, a website, www.upatrisk.com, was launched which highlights the attack by the Republicans in Lansing on the Upper Peninsula of Michigan: the prisons, universities, and more.

The website offers an easy online form to send a letter to legislators, and an easy form to spread the word to friends and families.

#### OFFICER RECEIVES LIFESAVING AWARD

As a result of actions taken in February of this year, Officer Pohl, Chapter President at the Brooks Correctional Facility, received the MDOC's Lifesaving Award in June.

Back in February Officer Pohl, a volunteer firefighter for the community of Spring Lake, arrived at a scene to find a woman suffering a heart attack. He used the external defibrillator to administer two shocks and restart the victim's heart. The family, victim and local fire chief all credited his quick response, calmness, initiative and professional skills for saving this life.

Officer Pohl also recently received a Citizenship Award for his commitment and making emergency care and training available in his area.

#### LIVE AMMUNITION

FOUND IN YARD



On June 26, 2005, a

prisoner at the Straits alerted an officer that he had found a live 32 caliber handgun round in the yard. The prisoner then lead the RUO and a Sergeant to where the ammunition was found. It was tied in what appeared to be the finger of a latex glove, and while tarnished, is believed to be usable.

Metal detectors were used to search the area, but as of this time, no additional ammunition has been found.

## Officer Attacked at Parr

On Monday, June 25th, an officer took numerous hits to the head and was knocked to the ground at least twice by a prisoner. Officers responded to the duress call quickly and intervened.

This was a level V prisoner who had been waived down to I, but was back as a PV.

The officer was taken to the hospital for treatment and released.

# Gender Lawsuit Moves Forward



In recent days, the MDOC

officially notified MCO of its intent to remove male officers from certain positions in female prisons. The Department indicated it would discuss implentation of the plan, however, MCO would be required to withdraw its appeal.

The MCO Board has rejected the conditions set by the Department and is continuing our appeal on the gender-based lawsuit to the U.S. Supreme Court.

This agenda was started by former MDOC Director, Bill Martin, in 1999. MCO has been fighting the issue for the last six years and will not compromise while we still have a shot in the Supreme Court.

The MDOC says it will move forward regardless.

#### INMATE AT KINROSS DESTROYS CELL

On July 1st, an inmate in the segregation unit at KCF became violent; destroying his door, trashing his cell and threatening staff.

Dressed out in cell riot gear with gas, staff lined up to rush the cell, at which point the prisoner decided to comply.

The inmate, after being placed in restraints, was transferred to the Chippewa Correctional Facility.

#### Alger Segregation Unit Wrecks Havoc

On July 5th, 2005, an inmate, returning to segregation after his major misconduct hearing, incited fellow Seg inmates to break out their cell door windows.

Within a short period of time, seven prisoners had broken the door windows, light fixtures, and began to flood their cells. One inmate broke out the back window as well. An eighth prisoner flooded his cell, but did no further damage.

The facility was locked down and the ERT team brought in to move prisoners out and place them in TOB restraints.

Two of the inmates resisted during the movement and chemical agents were used.

Several of the prisoners involved had come to Alger from I-Max in recent months.

Great job by all officers on duty and MCO commends the Alger Administration for their quick actions.

#### INMATE ATTACKS OFFICERS, BITING ONE

On July 8, 2005, a Level II inmate at MTU began to threaten officers and drag a chair down the hall. When ordered to put the chair down and go to his cell the inmate swung the chair, striking an officer.

A responding officer attempted to restrain the prisoner but was punched in the mouth with a closed fist. Two officers and a Lt. were finally able to take him down, however during the struggle one officer was bit on their arm.

The prisoner continued to struggle and the Unit was locked

down. Even once he was restrained in handcuffs and leg irons and being walked backwards to segregation, the inmate made threats against staff, continued to resist and at times had to be carried.

Two of the officers required treatment at the local hospital. One suffered a fractured thumb and possible spinal injury, while the other drank the "cocktail" and began treatment for HIV prevention.

## BACK TO BACK INCIDENTS AT HVM

On Monday, July 18th, a fight broke out between two inmates in one of the units. Yard and Unit staff cleared the day room and managed to break up the fight without sustaining any injuries. The inmates, however, were not so lucky and one was transported to the hospital for bite wounds.



On Tuesday, July 19th, a fight broke out in the big yard. Four inmates were fighting each other behind the field

house and there was at least one weapon in play. One inmate began chasing his assailant towards the tower, where the tower officer was in the window with weapon ready. The yard crew responded to the tower alert and broke up the fight before shots were necessary. No staff were injured, however, one inmate needed treatment at the hospital for a stab wound.

#### INMATE ESCAPES AT MOUND

On Monday, July 18th, a Macomb prisoner escaped while on a work detail outside the fence at the Mound facility. He remains at large and the incident is currently being investigated.

#### BUDGET UPDATE

The Legislature is now in the process of reconciling the two different Budgets that came out of the House and Senate. At this time all public hearings have concluded. However, MCO continues to work behind the scenes talking with legislators, the Governor, and other decision makers on this and other issues.

It is uncertain how long this reconciliation process may take, however some speculate that it could last all summer.

Please be vigilant in contacting your legislators and letting them know that making a fiscally irresponsible decision to continue the contract with the "punk prison" in these poor economic times is not in the best interest of Michigan citizens. Additionally, the proposed closure of Newberry and Camp Manistique is a poor operational decision and would further devastate the economy of Michigan's Upper Peninsula.

## SPEAKER DEROCHE CHANGES OPINION ON NEWBERRY CLOSURE

House Speaker Craig DeRoche made an announcement yesterday, July 27<sup>th</sup>, that he no longer supports the closure of the Newberry and Camp Manistique Correctional Facilities. Citing economists' projections that there will be more revenue than they projected in May, he believes that this additional money should be spent to keep the facilities open and lessen the cuts to NMU.

Representative Casperson spoke out as well indicating that lack of prison capacity and a greater understanding of the effect the Newberry Prison's closure would have on UP economics are key factors to consider.

This is not a done deal. There is a special Revenue Estimating Conference scheduled for August 17<sup>th</sup> where they will set a new revenue forecast for the current fiscal year ('04-'05) and for the fiscal year '05-'06. If it is determined that there are extra funds, it is DeRoche's belief that they should be used for Newberry and NMU.

The Senate appears to be wavering on their stance as well, however they will not make any decisions pending the outcome of the Revenue Conference.

MCO supported the UP fight and lead the downstate fight against these proposed closures... generating thousands of contacts from constituents to their legislators, lobbying of the administration and legislators, Letters to the Editor statewide and obtaining support from various labor and community groups.

The fight isn't over until it's over... so keep up the pressure and lets put this proposal to rest!

#### PRISONER FOUND GUILTY IN ATTACK ON OFFICER

An Ionia jury found a MTU prisoner guilty yesterday of "great bodily harm less than murder" for his part in the attack on Officer Jefferies last October. Officer Jeffries sustained serious injuries to his head and face from the assault which involved a lock-in-a-sock, requiring nearly 60 stitches and staples.

Another prisoner has also been charged in this incident however his case has not gone before a jury. It is being reviewed and we expect to have some movement on it in the next couple of weeks.

### INSURANCE OPEN-ENROLLMENT WINDOW

The time has come again when you have the opportunity to review and make changes to your group insurance. The Open Enrollment for State -Sponsored Group Insurance will be from August 15 - 31, 2005.

You will be receiving a detailed brochure in the mail shortly on how to make changes to any of your coverage. Your benefits will remain the same if no changes are made.

#### Shot Fired at Carson City

On Thursday, July 21<sup>st</sup>, two inmates began to fight in the big yard at Carson City. The responding officer was able to separate and restrain one of the inmates however the 2<sup>nd</sup> prisoner then turned and attached the officer.

The tower officer acted quickly and fired a warning shot, at which point everyone dropped to the ground. Responding yard officers then came on the scene and restrained the 2<sup>nd</sup> inmate.





## Assault on Staff at Camp Lehman

On July 29<sup>th</sup>, a prisoner entered the Control Center area without permission during formal count, a dispute ensued, and he left. The two officers who followed to cuff the prisoner sustained injuries in the process. Two assault tickets were written on the inmate and he was transferred to Standish.

At the time of the assault, one housing unit rover had been pulled off assignment to work the visitor room.

The Camps have seen a dramatic change in the type of prisoners they receive in recent years. At one time, Camp Lehman had approximately 340 inmates, 250 of which were crew eligible. As of two days ago, they had approximately 570 inmates, with less than 50 of them crew eligible.

Lehman currently has only 70 staff to handle these increased numbers.

#### OFFICER ATTACKED AT MARQUETTE

On Monday, August 1<sup>st</sup>, an officer was attacked while locking up prisoners after morning chow. Video footage shows that the officer was unlocking a cell on the 2<sup>nd</sup> gallery when he was sucker punched from the side by an inmate. Despite the prisoner's attempts to change his appearance after the attack by removing a cap and rolling down his pant legs it was determined that he was the only one in the area.

The officer required hospital treatment for his injuries. Marquette has been fighting lower critical staffing levels, and picketed in June.

## ESCAPED INMATE AND WORKER CAUGHT

On Saturday, August 6<sup>th</sup>, an inmate from the Baraga Max facility escaped with a food service supervisor.

The pair were eventually tracked, through their use of a cell phone, to northern Wisconsin where they were arrested just after midnight on Sunday.

The inmate, who was serving six life sentences and had escaped on two other occasions while in the Saginaw County Jail, has been extradited and is now at Marquette awaiting further charges. The food service worker is fighting extradition and is in jail in Marathon County Wisconsin on \$50,000 bond.

A food service officer has also been arrested and charges will be filed for assisting the escape.

The Union has been assured by the MDOC that it was not the fault of the other Baraga officers that this occurred.

We want to acknowledge the officers at Baraga who have been struggling over this situation. While it may be easy to take this personally, you did your job!

#### Hang in there!

#### CMI TO BECOME LTD ADMINISTRATOR

## ATTEMPTED ESCAPE AT

CARSON CITY On August 5th, a prisoner, who



had just arrived from SLF that day, walked up to the fence and attempted to escape. In his own words, "I was going to climb the fence. I want to go home."

When the prisoner arrived at Carson City he was instructed to report to the Food Service building to eat, then to Health Services, and finally to his Unit. He did report to Food Services, eat, and leave. But instead of reporting to Health Services, he was spotted by the tower officer approaching Zone 9 without permission. The tower officer ordered the inmate to halt, however he continued to the fence and set off the alarm in the Control Center.

Responding ARV and yard officers instructed the prisoner to lie down to be restrained at which point he complied. It was at this time that he confirmed his intention to climb the fence.

A major misconduct was written for attempted escape and he was placed in segregation. It was determined that further evaluation of the prisoner was needed and at this time a transfer is pending.

#### OFFICER BRUTALLY ATTACKED AT I-MAX

Yesterday, in a housing unit at I-Max, an officer was beaten in the face and head by a prisoner. The officer remains hospitalized after receiving two breaks to his orbital bone and a broken nose, which will require extensive surgery at a later date to repair.

Two other officers were also injured while taking down the prisoner and placing him in cuffs, leg irons and a spitter's mask. The

inmate continued to resist and threaten staff while being restrained. In all, nearly twenty officers responded. The inmate remains in segregation.

This particular prisoner has a record that includes 7 "Assault on Staff" charges. Incidents like this further our concern and push our argument on the current classification system and the need for a Level VI Prison.

#### STATE HAS GREATER THAN EXPECTED REVENUE

A special Revenue Estimating Conference was held on Wednesday, August 17<sup>th</sup>, where it was determined that due to greater than anticipated revenues, the General Fund will have a net year-end balance of \$65.6 million for FY '04 - '05, and \$75.6 million for '05 - '06.

What does all of this mean? Well, it means that there may be enough money to keep the Newberry and Camp Manistique Correctional Facilities open. *However*, there are a lot of hands in the pot for these funds and it is expected to be several weeks at best before any decisions are made. Stay tuned!



#### MCO MOURNS LOSS...

#### OFFICER IN TENNESSEE GIVES ULTIMATE SACRIFICE

Officer Wayne "Cotton" Morgan was fatally shot

while escorting an inmate from a hearing in Kingston, Tennessee on August 9, 2005.

Officer Morgan was shot by the wife of the inmate; a former prison nurse who had been fired last year for sneaking food to a prisoner. She and her inmate husband then escaped and eluded police for two days before being captured in Ohio.

These are challenging times; we need to uphold the integrity of our profession and the security of our institutions.

#### **TWO CRITICALS IN TWO** WEEKS AT LAKELAND

The first incident occurred when an agitated prisoner who had been pacing, speaking unclearly, and yelling, began walking toward food service. As he neared the gate the inmate swung a fist at two officers who then tried to restrain him. He resisted, landing on the ground.

Once cuffed, he was escorted to Temp. Seg. and placed in a shower/dress out area to be processed. While there he became argumentative and refused to be processed for nearly an hour before finally complying.

Four officers received injuries while restraining the prisoner.

The second incident occurred when an inmate became upset being moved over to a different housing unit. He was agitated, swearing, and threatened the RUM. He was ordered to turn around to be cuffed however he refused, continued to resist, spit in the RUO's face, and attempted to strike the RUM. It required numerous officers to eventually restrain and cuff the inmate, all while there were 20-30 prisoners in the area as the Unit store was being passed out at the time. The RUO required treatment for blood exposure.

#### MURDER-SUICIDE AT BELLAMY CREEK

Police are investigating an apparent murder-suicide involving a Sergeant and a Food Service Worker from Bellamy Creek. The two individuals, Beth Thompson and Edward Elvert, were found shot to death the morning of September 1<sup>st</sup>, by Thompson's daughter.

Elvert was hired in 1981 and promoted to Sergeant in 1986 and Thompson had worked in food service since 1998.

The case is currently under investigation by the Sheriff's Department. No suicide notes were found.

## Oaks Assault Leaves Two Hospitalized

On August 29<sup>th</sup>, a prisoner failed to report to the dayroom and lingered in the B-wing base housing unit. After ignoring repeated orders to report to the dayroom, the RUO exited the bubble and ordered the inmate to lockup. The prisoner turned and struck the RUO in the face with a closed fist, took him to the ground, and continued to kick him in the face and left chest. The A-wing RUO responded and attempted to stop the attack, but she was struck in the left eye area and fell to the ground as well.

Responding officers ordered the prisoner to calm down and he was successfully placed in restraints and sent to segregation without further incident.

An ambulance was called -one officer required a stretcherand they were taken to the hospital. Both officers were admitted and both required surgery. One sustained two broken ribs, a nose broken in two places, and cuts to the face. The other officer had her left orbital (eye) socket blown out.

The inmate involved was a Level IV serving time for Uttering & Publishing and Assaulting an Employee/Escape.

# **BUDGET AGREEMENT REACHED**

FUNDING FOR NEWBERRY AND CAMP MANISTIQUE!

This morning a tentative "target agreement" was reached between the Governor's Office and both Houses of the Legislature. In addition, the amounts going to every budget were agreed upon and will not be changed.

The next step calls for each budget to go through Conference Committee. The Conference Committees will be established next week with members from each House. Thus, there will be a Conference Committee for Corrections, one for DCH, etc.

After the Committees have reviewed their budgets, they will report them out and each House will have to vote.

It is our understanding at this point that our efforts were successful and the "target" includes funding for the Newberry and Camp Manistique Correctional Facilities.

Congratulations to the Newberry officers, community, and MCO members statewide who lobbied and influenced decision makers in this effort.

Funding for the youth prison in Baldwin is included in the "target" as well. MCO continues to lobby the Administration to end the State's contract with MYCF.

### Prisoner in MTU Attack Sentenced

The primary assailant in the

October 2004 attack on Officer Jefferies at MTU was sentenced to 9-20 years for "Assault with intent to commit great bodily harm less than murder" by an Ionia jury on September 6th.

Officer Jeffries was beat with a lock-in-a-sock and ended up with lacerations to his face and head requiring nearly 60 stitches and staples.

The other inmate involved was charged and sentenced last month.

### PROBATIONARY OFFICER STEPS UP

A Probationary Officer at Macomb acted quickly and effectively last Saturday, September 3<sup>rd,</sup> when an inmate came out of food service clutching his throat and unable to respond when asked if he was okay. The Officer applied the Heimlich maneuver accurately and the prisoner's life was potentially saved.

Kudos for the keen eyes and quick actions! Keep it up!

### **BUDGET AWAITS GOVERNOR'S SIGNATURE**



The House and Senate approved H.B. 4831, which is a combination

of several budgets including Corrections and Community Health. The bill includes funding for both the Newberry and Camp Manistique Correctional Facilities as well as the privately run youth prison in Baldwin.

MCO continues to pressure the Governor to line item veto the funding for the private prison when the Bill lands on her desk.

### NEW CLASS TO START OCTOBER 24TH!

A new class, consisting of 120 new employees (50 of which are female), will be the first class to move through the Michigan State Police training facility.

The new class will help lessen the impact of the changes at female prisons and will facilitate transfers of officers frozen at the Huron Valley Complex as a result of the HVC closure.

Most of the cadets are slated for the UP, Coldwater, and the female facilities.

Another school is scheduled for January 2006, with an additional 100 or so cadets, to help fill vacancies statewide.

### GOVERNOR VETO'S MYCF FUNDING!

Governor Granholm today signed the Corrections budget which includes funding for both the Newberry and Camp

Manistique Correctional Facilities and she vetoed the funding



for the Michigan Youth Correctional Facility in Baldwin.

MDOC officials are already meeting with employees at the facility about state job opportunities and plans are being made to move the prisoners into the MDOC system over the next two weeks.

### FIVE OFFICERS INJURED IN CRITICAL AT I-MAX

On Friday, September 23<sup>rd</sup>, a Level II inmate, upset that his gambling game was broken up, went to his cell, grabbed one of his socks, filled it with a cue ball, and then attacked the officer who shut down the game. The officer sustained serious injuries to his head and chest, as well as a concussion. Four responding officers also required hospital treatment for their injuries and all are still off of work at this time.

### BILLS INTRODUCED FOR GENDER BASED ASSIGNMENTS

Two bills were introduced this week in the House by Representatives Lemmons III, and Lemmons, Jr., that pertain to the Michigan Department of Corrections.

These Bills, HB 5219 and 5220, add language that would require **only female** employees to hold CO and RUO positions at female facilities and **only male** employees to hold CO and RUO positions at male facilities.

MCO absolutely opposes these bills and will fight them as they move through the legislative process.

### OFFICER NEEDS OUR HELP

CO Doug Larivee from HVM has been suffering from several severe illnesses and needs our help. Fellow officers recently donated the maximum number of sick leave days allowed under our contract (30 days) as Officer Larivee had already exhausted all of his leave options.

### Two Criticals at Marquette in one Week



During lunch movement on Wednesday, September 14<sup>th</sup>, one inmate turned and attacked another in the yard, striking him about the face and neck with a closed fist. There were no officers in the immediate area and thus the tower officer fired a warning shot to break up the brawl. Everyone hit the deck and officers responded to the scene and gained control.

On Saturday, September 17<sup>th</sup>, two prisoners began to fight in the yard. A responding officer took one inmate to the ground. The other inmate, however, continued to kick the pinned prisoner and struck the officer in the process. Another officer responded and restrained the second inmate, but he sustained injures during the struggle with the resisting prisoner. Both officers were taken to the hospital where they were treated for a variety of injuries including concussions, contusions, and one has a chipped bone in his elbow.

### U.S. SUPREME COURT REFUSES TO HEAR MCO'S GENDER BASED LAWSUIT

MCO received notification today, October 3, 2005, that the Supreme Court denied the Petition for a Writ of Certiorari, meaning that Court has declined to review the Sixth Circuit's decision in the gender based lawsuit.

Back in June of this year, with MCO's support, Corrections Officers Roslyn Everson, Randy Fox, Stennis George, Richard Idemudia and Brenda L. Sebastian filed a Petition for a Writ of Certiorari with the United States Supreme Court, seeking review of the Sixth Circuit's decision in Everson v. Michigan Department of Corrections, 391 F.3d 737 (6th Circ 2004).

The Sixth Circuit's decision reversed a decision by United States District Judge Avern Cohn, which had found that the Department violated Title VII of the Civil Rights Act of 1964 by removing all male officers from the housing units in the female prisons and replacing them with women officers. Judge Cohn concluded that the Department had failed to prove that gender was a bona fide occupational qualification for the position of Corrections Officer, based on evidence that some male officers—only a very small minority—might engage in sexual misconduct with female prisoners—and therefore that the blanket exclusion of all male officers was unjustified.

The Department's efforts to remove males from housing units began back in 1999 when Director Bill Martin ordered it done during settlement discussion with the US Dept. of Justice under the Engler Administration in response to challenges from several women's prisoner advocate groups.

MCO has fought this for the last six years through every step of the court system maintaining that "a uniform is a uniform" regardless of gender. While we have lost this fight...we are doing everything we can to mitigate the impact, including lobbying for 50 females in the new class who are being hired specifically for those positions, thus limiting forced movement of existing members.

### PRISONER KILLED AT CAMP CUSINO

On Monday evening, October 3<sup>rd</sup>, a prisoner at Camp Cusino was fatally stabbed in the chest with a prison-made weapon.

The inmate, David Allan Green, of Bridgeport, 21, was serving time for larceny and felonious assault. His earliest release date would have been approximately one month away.

Two prisoners are suspects in the murder at this time; one of whom has 10 Major Misconducts and 5 Minor Misconducts on his record. The second suspect was charged with possession of dangerous contraband *prior* to his placement at the Camp.

It is MCO's view that **these inmates should not have been housed in a low security facility** and MCO continues to be concerned that because of continuing budgetary pressures, the MDOC will be too lenient in classifying prisoners and may waive them down to lower level prisons to save money.

MCO President Tom Tylutki spent the last couple of days touring Camp Cusino and other UP facilities. A Labor Management meeting is being set up to discuss issues raised by the officers during his tour.

### CHANGE IN PHARMACY CO-PAY FOR SELECT DRUGS

Effective October 1, 2005, the co-pay for "non-formulary brand name" drugs increased from \$15 to \$30. For an up to date list of formulary drugs, call Express Scripts at (800) 505-2324 or visit them on the web at www.express-scripts.com.



This list changes regularly, so while you may see a drug listed as formulary on the web, you should confirm it with Express Scripts via the phone before changing prescriptions.

To limit your costs if your prescription is non-formulary, either ask your doctor if there is an alternative drug that **is** on the formulary list, or use the mail order service to receive a larger supply of your medicine per co-pay.

### **MDOC OFFERS JOBS TO YOUTH PRISON EMPLOYEES...** Makes Plans for Their Transition to the State Prison System

As you know, the Michigan Department of Corrections has been meeting with the employees of the Michigan Youth Correctional Facility in Baldwin since the days following the Governor's veto of their funding. The MDOC has extended job offers to those employees of MYCF that are interested and are currently "auditing" their records for verification of their credentials. Upon employment with MYCF, these Corrections Officers were required to go through the same 16-week Academy and meet the same requirements as established by the MDOC, even though they were to be employed at the private facility.

While most of these officers have already met the requirements and taken the necessary training, they will need to attend some form of "Orientation to the MDOC." If, after the audit, the MDOC finds that there are some individuals who do not meet the standards, they will make them go through the Academy prior to employment.

It is also the Union's understanding that MYCF Supervisors will need to go through the MDOC Training Academy and will start out working as Corrections Officers. All new officers from MYCF will start out like any other "new hire"...with zero State time and zero seniority within MCO.

The fight MCO launched against the punk prison during the recent budget battle was not one of pitting one community against another, nor officers against officers. It was a philosophical fight; related to wage, benefit, and safety issues, and dates back to the opening of the facility in the mid-90's. The recent efforts by MCO members statewide to save the Newberry and Camp Manistique Correctional Facilities show just how effective we can be when we all work together; with solidarity and determination. MCO supports workers, and is hopeful that the addition of these officers to our ranks will ease staffing shortages and increase safety on the job. Brothers and Sisters of MCO, please welcome these individuals as they enter the State system, and let us work together as we have many more battles before us.

### UNIFORM ALLOWANCE TAXES CLARIFIED

has received recently indicates that there is confusion regarding the taxation of the Uniform Allowance.

The IRS requires that taxes

The be deducted from payments that are considered to be "nonaccountable." A non-accountable payment means one in which no receipts are required to substantiate the payment. MCO has verified this through our independent CPA Firm.

Thus, to ensure IRS compliance, the HRMN system has been changed to deduct the Income

taxes, Social Security, and Medicare taxes at the time the payment is made.

The Uniform Allowance has always been subject to these taxes, however in previous years the taxes were paid at the time of tax filing rather than at the time of payment.

### WEAPON USED IN CRITICAL AT I-MAX

A fight broke out in the chow hall at I-Max on October 27th between two prisoners. What started out as a verbal incident escalated to exchanged punches with clenched fists and then the introduction of a homemade weapon.

The responding officers did a great job in separating the two inmates before more serious injuries occurred. And, more importantly, they did it with minimal harm to themselves.

As it was, the inmates sustained severe lacerations to their arms, cheek, and mouth. One inmate sustained a cut the full length of his face and sustained substantial blood loss. Both inmates required hospital treatment for their injuries. Luckily only one officer required treatment and that was for possible blood exposure.

Once again recognition needs to go out to the officers for getting this dangerous situation under control safely.

Although the Department has indicated its continued interest to classify gun towers as an E-8 position, it is putting the issue on hold for the moment.

Officers from the former private youth prison started at MDOC facilities this week. MCO has met with some new hires and hopes to reach all within the next week or so.

## UPDATE ON OFFICER'S PASSING

It was determined that Officer Bullock, 35, of the Scott Correctional Facility, suffered a massive heart attack on the job.

She leaves behind four children, under the age of 13, who will be raised by her sister.

Vice President Andy Potter attended the funeral services and presented the family with a MCO Memorial Bible and a check from the MCO Crisis Fund.

### LOCKDOWNS AT MTU

Twice in as many weeks, MTU has been locked down. Two weeks ago it was due to an assault between two prisoners over coffee. On Wednesday night it was over an alleged cell theft. The incidents appear to be racially motivated.

Thus far, no staff have been injured and no weapons have been used, however one was found during shakedowns yesterday.

### BUDGET DRIVEN CORRECTIONS HITS SEG UNIT AT KINROSS

Since the Kinross Correctional Facility added 296 inmates in June, its segregation unit population has exploded. For the past month it has been full beyond capacity and as a result the KCF Administration has been releasing prisoners from seg early. At times, as many as 5 inmates in one day have been released, and at least one inmate had as many as 10 days left in his detention.

The segregation unit has 4 empty seclusion cells on the upper two floors of the unit. However, the Administration refuses to use them because it may create overtime.

This is a clear example of money driven corrections. In

### SENIORITY BASED TRANSFERS

The Seniority Based Transfer window period is open now through November 31<sup>st</sup>.

To apply, the request must be placed in writing and submitted to your personnel office.

For more information and the conditions in which vacancies are filled based on seniority, look to your contract - pgs. 78-79, Article 15, Part D, Section A, #2. addition, the Warden recently considered using two of these cells, on a general population floor, to house MRSA quarantine cases with the cell doors being left open.

The increase in the KCF Seg population is mainly due to inmate fights. At this time, 35-40% of the inmates in the Seg unit are there for fighting. The remainder of the Seg population consists of inmates threatening staff, unmanageable inmates, and other misconduct problems.

With winter fast approaching, MCO knows that inmate assaults and fights will increase, as well as MRSA cases. The KCF chapter and MCO will be closely monitoring this ongoing situation.

### Shots Fired at Marquette



On October 25<sup>th</sup>, and again on the 28<sup>th</sup>, shots were fired from the Gun Tower to break up inmate on inmate fights in the yard.

No staff were injured and officers were able to regain control.

### CRITICAL AT NEWBERRY

On November 15<sup>th</sup>, an officer was escorting a non-bond prisoner to the hearing inspector. As they were passing down the hallway between units an inmate jumped out and attacked the officer punching him in and about the face. Responding officers intervened and thwarted further assault.

The officer sustained bruises and lacerations to his face and head. He was sent to the hospital for treatment and later released.

### **C**LARIFICATIONS ON

### **OFFICERS FROM BALDWIN**

While it was understood from the beginning that the officers joining the MDOC from Baldwin were to be considered green tags in terms of seniority, overtime and state time...the issue of whether they would actually wear green tags has been in question. The original indications were that they would be issued black tags.

MCO has been actively arguing against this and received notification this week that they will, in fact, be wearing green tags.

In addition, they will be required to qualify with a shotgun. Rifle qualification is optional and at the discretion of their intended facility.

### CHIPPEWA SEES RASH OF SHANKS

On October 22<sup>nd</sup>, a fight broke out between four prisoners - two of whom had weapons. Skillfully, officers were able to break up the fight without sustaining any injuries.

This is just the tip of the iceberg, however. Since November 1<sup>st</sup> there have been 12 incidences where shanks, other weapons, or dangerous contraband have been found, either hidden within the facility or in the possession of an inmate.

### CO ELECTED MAYOR OF MANISTEE

Robert "Chip" Goodspeed, who with 424 votes recently won re-election to his third term as a city council member, was just elected as the Mayor of Manistee.



The city's charter directs that the city council appoint a Mayor each year from among the city council members. Goodspeed was just starting his fifth year as a councilman and was nominated for the mayoral position along with the incumbent.

Goodspeed won the election in a 4-3 vote.

Goodspeed, a CO at the Oaks, has been with the MDOC for nearly 10 years. Way to go Chip!

### **CIVIL SERVICE AUDITS GROUP INSURANCE ELIGIBILITY**

As you recall, during the Group Insurance Enrollment held in August of 2004 all employees were asked to review their covered dependents. At that time an amnesty period was established for employees to drop ineligible dependents without suffering a penalty.

During fiscal year 2005 the State of Michigan began a statewide audit of dependents. MCO informed our members of this undertaking in the May issue of the MCO Report.

A mailing has gone out to all MDOC employees who have dependents enrolled in state sponsored group insurance plans

requesting documentation such as birth certificates and marriage licenses to prove their eligibility. Responses are due by January 20, 2006.

If you have any questions or need direction in locating the requested documents, please refer to page two of the cover letter you received for contact numbers and related websites.

limited to, removal of dependents from benefit coverage, recovery of premiums and claims paid for ineligible dependents, and where appropriate, other corrective action. MCO is under the impression that they are exploring disciplinary action as well.

In addition, if your dependents are removed for lack of response, you will not have the opportunity to re-enroll eligible dependents until August 2006.

It is critical that you start the process of gathering your information as soon as possible. With the holidays falling during the submission period, it may become difficult to obtain official documents from state offices in a timely manner in order to meet the January 20th deadline.

### **ESCAPE MATERIALS AT KINROSS**

The 3-11 shift was locked down on December 8th after the Inspector received a tip that there was escape paraphernalia in one of the four-man rooms.

A grappling hook and other materials

were found exactly where they were supposed to be according to the tip.

MCO Recording Secretary Jim Johnson, who works the unit where the materials were found, stated, "That's why minimum staffing levels are necessary...with the huge yard area at KCF, I feel we still fall short of proper staffing. It shouldn't take a serious incident like this to make the Department notice shortfalls."

### **ESCAPE AT GUS HARRISON!**

Two inmates, serving time for murder and rape, escaped this morning by hiding in the Trash Compactor truck.

They were spotted when they left the truck and the police were notified. They stole a vehicle and drove to Blissfield where they were apprehended within 40 minutes of the escape.

One of the prisoners was treated for a broken leg.

### SENATOR SCHAUER FIGHTS FOR MCO, TAKES ON **PRIVATIZATION**

State Senator Mark Schauer rolled out two new bills requested by MCO in a press conference at MCO Central on Monday.

The first of his bills would mandate that all prisons in the state of Michigan be run by the Michigan Department of Corrections.

The second bill simply removes language that was added to PA 232 in 1996 that referred to the youth prison and privatization.

When the legislature recieves a bill number MCO will pass along that information so that you can read the full contents and then contact your legislators and let them know your views.

The passage of these bills would end the threat of private prisons in Michigan for good.
