#### MCO STAFF REALIGNMENT SUMMARY OF NEW AND UPDATED POSITIONS

# Former Labor Reps Tangee Laza and Karen Mazzolini are now Member Engagement Directors. They will:

- Lead teams charged with engaging members around pressing issues and interests, training leaders, and growing MCO's power;
- Identify, recruit and develop worksite leaders and volunteers to become involved in union activities;
- Build and maintain special interest committees;
- Plan and execute large scale member led activities;
- Oversee MCO training programs.

### Former Labor Rep Cherelyn Dunlap is now the Member Benefits Director. She will:

- Educate members, develop new benefit offers, and resolve issues relating to benefits;
- Manage member benefit programs including health and pension programs;
- Oversee member discount programs and search for new opportunities;
- Investigate and resolve members' issues with health care coverage, FMLA, retirement, workers' comp, etc.

## Former Labor Rep Jeff Foldie is now the MCO Legal Director. He will:

- Lead a team of 3 to handle all contract related issues;
- Manage and execute the grievance and arbitration processes;
- · Manage outside counsel as needed;
- Assist with contract negotiations.

These aren't the only staff changes at MCO.

## Jeremy Tripp is now the Government and Political Affairs Director. He is in charge of:

- Government Relations/ Direct Lobbying;
- Legislative Strategy and Political Endorsements;
- Policy Research and Advocacy Assistance;

## Cindy Kogut is now the Finance and Human Resource Coordinator. She is in charge of:

- Overseeing certain personnel functions, including new employee orientation, payroll, timesheets, employee records;
- Processing expense vouchers;

- Media Contact/Press Releases;

- Confidential liaison to the Chief of Staff;
